I, ASI Dilip Halder of Bagdogra Police Station, SPC do hereby lodged this written complaint against the above noted arrested person namely Somaru Roy 58 yrs s/o Late Sashodhar Roy R/o Rupsingjote PS, Bagdogra Dist, Darjeeling to the effect that on 08.05.22 at evening in course of K-36 Mobile van duty vide GDE no 282 at around 13.30 hrs received a secret source information that one person is selling huge quantity of illicit liquor from his hotel located at Rupsingjote near Fish Market and as per your kind instruction, I along with C/522 Anil Barman, C/514 Urendra Nath Singha, VP-01 Ansalam Kujur and VP-02 Pradip Roy left for Rupsingjote fish market area to verify the veracity of information.
