With due respect, I. PSI Sumit Rawat of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint agairst accused namely: Ajay Giri(33yrs) S/O- Awadh Giri of Tikiapara, 01 No Matangini Colony, Ward no- 28, PS- Siliguri, Dist- Darjeeling after producing him under arrest along with following articles;

 20 (Twenty) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml Rs. 120/- each total 7.2 Ltrs (Valued total Rs. 2,400/-), under proper seizure

list, labeling and memo of arrest.

In this regard I beg to report that on 06.05.21 at 19.05 hrs, I along with other officer and forces left for conducting raid against illicit liquor vide Siliguri PS GDE No. 343 Dated: 06/05/22 While conducting special raid against Illicit liquor at the house of Ajay Giri(33yrs) S/O- Awadh Giri of Tikiapara. 01 No Matangini Colony, Ward no- 28, PS- Siliguri, Dist-Darjeeling on the strength of secret source information that Ajay Giri had stored and selling huge quantity of illicit Liquor at his house without any valid documents. I shared the information with 1. C. Siliguri PS over telephone and as per his direction without making any unnecessary delay as shown by the secret source, at 19.45 hrs I conducted raid at Tikiapara 01 No Matangini Colony and on being shown and identified by the source apprehended one person with plastic gunny bag, which contained above noted seized bottles of illicit liquor and on interrogation he admitted that he had been possessing the above noted seized articles and selling it to the customers in concealed manner in public places. In presence of witnesses, I demanded him the papers or license of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the customers for his wrongful gain. I, accordingly seized those illicit liquors in between 20:05 hrs. and 20.45 hrs in presence of witnesses namely Biswajit Sarkar(26yrs) S/O- Bichitra Sarkar and Sudip Pande(31 yrs) S/O- Lt. Ramji Pande both of Tikiapara 01 No Matangini Colony, Ward no-28, PS- Siliguri, Dist- Darjeeling after preparing proper seizure List duly signed by the witnesses and accused and also labeled the same. Then, I arrested him U/S 41 CrPC after informing his ground of arrest.

As the above noted seized articles are to be suspected of Illicit Origin and possessing the same illegally. I, therefore, pray before you to take legal action against him under proper section of law.
