Iti Karmakar that to remove the tenant from my rooms and I want to reside at my house but suddenly they lock the main gate and started beating my wife by fist and blow, kick and they mercilessly beaten my wife thereafter my wife started shouting "Bachao Bachao" and all the para people any my elder brother Sri Nimai Karmakar and his wife Smt. Monika Karmakar came to the spot to recued my wife but they did not open the main gate and said Souvik Karmakar and my elder brother Sri swapan karmakar random beat my wife and said Gullu @ Souvik Karmakar trying to outrage the modesty of my wife and they torn her churidar and trying to rape her by saying that if we come again to reside into the house they will rape my wife and they murder me.

That thereafter all the para people requested to open the main gate then one tenant open the main gate and I along with my another elder brother Sri Nimai Karmakar entered into the house and my elder brother Nimai Karmakar started to capture the said incident through mobile phone suddenly said Souvik Karmakar @ Gullu Karmakar
