Further maintaining his decency and observing all formalities searched him and recovered huge amount of above noted seized liquor with one carrying bag from his possession. On demand he could not produce any valid documents/licence in respect of the recovered liquors. On enquiry the apprehended persons admitted his guilt and confessed that he has possessed above noted liquor at his house for the purpose of selling to his designed customers. He also stated that he has been doing this illegally since long without any valid licence or Documents for his wrongful gain.
