Sir,

In producing here with the one arrested accused person namely Bhupen Roy (55) S/O- Lt Bhognarayan Roy of Ektiasal, PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- (I) 20(twenty) Bottles of Himalayan Gold 60up Country Spirit each Bottle containing 600ml. (Total 600ml X 20=12Ltrs.) And marked as Exhibit - A.
- (II) 01 (One ) bottle of Himalayan Gold Spirit containing 600 ml, taken out randomly from Exhibit A for examination and marked as Exhibit A-1.
- (III) 02(two) Bottles of Tuborg Premium Beer each Bottle containing 650 ml. (total 650ml X 2=1.3Ltrs.) and marked as Exhibit - B
- (IV) 01 (One ) bottle of Tuborg Premium Beer containing 650 ml, taken out randomly from Exhibit B for examination and marked as Exhibit B-1.

I, ASI Nitai Mandal of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 08.05.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No.434 Dated. 08.05.2022 at about 14.45 Hrs I, received source information that the above noted accused person have possessed huge amount of Liquor carrying in a carrying bag at near Payel More under Bhaktinagar PS for the purpose of selling the same to local customers. Accordingly the information shared before you and as per your kind direction I along with ASI Dipak Karmakar Constable C/986 Rajib Sarkar, and CVF-014 Labanyamoy Barman headed towards near Payel More to verify the veracity of the information. We reached at near Payel more as shown and being identified by the source held raid and apprehended one person who disclosed his identity as noted above. Further maintaining his decency and observing all formalities searched him and recovered huge amount of above noted seized liquor with one carrying bag from his possession. On demand he could not produce any valid documents/licence in respect of the recovered liquors. On enquiry the apprehended persons admitted his guilt and confessed that he has possessed above noted liquor at his house for the purpose of selling to his designed customers. He also stated that he has been doing this illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 16.35 Hrs to 17.05 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising his ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Bhupen Roy (55) S/O- Lt Bhognarayan Roy of Ektiasal, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
