**SUBJECT-APPLICATION REGARDING MARRIAGE LIFE DISPUTE AND VOILENCE
BY HUSBAND AND INLAWS.**

Respected madam,

With humble request, I Diksha Thapa d/o Lt Gopal Singh Thapa resident of vill: Chandbarjote, near bsf headquarters camp, P.o Kadamatala, PS- Matigara, Dist: Darjeeling 734011 would like to beg to state that Madam, I am highly disturbed mentally, physically, socially due to my marriage life. I am a staff nurse working in North Bengal Medical College and Hospital since last 3 years in service still. In 11th march 2020, I was married to Mr Manoj Kumar Chhetri s/o Madan kumar chhetri in presence of both my families and his family in MAHESWARI temple, Champasari. As he belongs to a brahmin (ksthriya) family, I had already notified him before marriage that I am a non brahmin girl. Still with all cons and pros he decided to get me married with him as he was already on his 30s and was working in AMITY UNIVERSITY AIC as DEPUTY MANAGER, office situated to Iskon Mandir Road, Siliguri. We were then residing in as RENT in Phasidewa More near Yakthung Shivamndir after marriage as husband and wife.

Few days later (15 days later) when I just asked him his about salary details for buying household items, he just denied me of giving as he was running out of money. When I asked him about his debts he said in a harse manner as if to beat me up that he was running in debts of 1 lakh and some Emi's of bike and his phone. I was still mentally disturbed still carried on thinking of coping up the matter by adjusting itself. On my visit to my in laws house, my mother in law would always demand me money so I would give them 5000 and 10000 instant always if I had thinking them as my mother and father as I have none of my own alive.

Then later on 16 April 2020, I came home after evening shift. I had cooked and slept. Around 12pm to 1am I found him blacked out in my hall room with 1 liter of alchohol in his hand. I was terrified with the incident I immediately called my sister for help. When my sister arrived he some how gained his consciousness and got up and started holding my wrist and saying how dared you call your family to insult me. I was broked and shattered still managed to stay. Next day when I had morning shift I went duty. When I came back from duty again he was not at home, I called him many times but he didn't lift the call till 10 pm. I was so tensioned it was severe lock down scenario, still I gained courage and went to his friend Firoz Pradhan rented flat to search him at 1 pm in my scooty thinking of no fears and with full tears. When I reached there Mr. Firoz Pradhan denied that he wasn't there. So I had no option then returning to my rented home. He didn't come home for 2 to 3 days still I used to call him up. He didn't neither call or texted me. Later he came after 3 days still I was quiet thinking of not extending the matter.

After next few days we had a small dispute regarding dining table matter, again he went out with his bike and bags with laptops for 48 hours. I called him continuously but the same thing he didn't come for 2 days. Later I was so harassed that I called his parents who knew the previous matter too. I said my family and his parents and some of relative for a family meeting because without my knowledge he is roaming or going somewhere without my concern. Meeting was done they said he wont repeat this again. Again I forgave him. Such family meeting were done more than 3 times. Still I forgave him thinking of better tomorrow.

Again after 2 months he went home saying me that he has some work so he will be returning after a week. I was like ok you can because I cant go as of my duty schedule during covid breakdown. Days passed he didn't come after a week, he started again not receiving my calls or messages. Even his

parents started not receiving my calls. Later I took permission for travel pass from Matigara police station to travel hamiltonganj along with my family and visited my in-laws house and found he was not at home. Then his parents started pointing, blaming me out of not having there son home. After few hours I see him in his bike coming from his friends house. Now even his parents started lieing to me. Still they asked for apology still my family accepted and said not to repeat again. I went back and he came after 1 week.

On December 2021, before reception I was diagnosed Pregnancy positive by a kit. And yet it was his birthday on 1st Jan so I decided to visit Kamakya temple Gwahuati. We went on 30th January and reached on 31st. We booked a hotel and stayed at midnight 11pm 31st Jan again he started getting drunk and started abusing me and hitting on my stomach knowing that I was pregnant. I was on so much pain still somehow managed to overcome situation and came out of the hotel room and stayed at terrace and came down at late 4am. On gaining consciousness at morning he asked apology and again I was convinced like a fool and went to kamakya temple. We returned back home by train on 2nd January after the darshan of lord.

We had our reception on 2021 24th Jan in his house and 14th february in a hotel through my family. I was given gold earning, gold bangles and gold mangasutra worth Rs 1lakh from my inlaws. Where both of our family were invited in both receptions. During his family reception preparing his mother and his aunties directly called me in room and started demanding for some money for help as they were unable to meet needs for some decorations or charges. I still thought as daughter and gave them a lum sum amount of 70 thousand in cash by borrowing it from one of my colleague Mr Gopal. Our receptions were over we headed back and joined the duties again.

On 27th January he said me to abort not revealing it to any of my family as we are running out of budget for later expenses, so he brought some medicine from clinic and gave me. On 30th January I started having stomach pain on my duty hours. I came back home and saw that I had a miscarriage and informed him immediately with a photo. Still I was alone at home the very same day washing my own and his clothes and took a painkillers and slept. But my sister Sunila knew that I was pregnant and was said to abort as she had came to visit me the same day I had a miscarriage.

Days passed and again he started getting lost for 48 to 72 hours. I was fed up of searching and asking for help door to door. Later on day he was again drunk in room and again blanked out of consciousness. I caught hold of his phone and checked his whatsapp, messenger and photos. I found that he was in a linkup with a woman called Orpana chhetri and many more woman. I started to record his messages with other woman too. I was heartbroken still was quiet and went to my parents' home. When I came next morning, I saw his bike was in parking, his bag was inside, his laptop was there. I started checking his bag and saw. He had went to a lawyer and wrote a GD (GENERAL DIARY) in reference to matigara police station against me stating of me harassing him. I was shocked and stated this my family. They said me to bring that GD papers. Two days passed by I had no other option then searching him again. I went to his friends Mr. Mohan office in champasari where his brother gave me the information that he was roaming with this Mr Mohan for past two days in sevoke location along with other friends named Sadan and Amit Yadav. Immediately I went to Mohan's resident. When I asked about Manoj all of a sudden Mohan and his family started shouting at me for coming at his home. I gained courage and warned him to inform Manoj to return by 10 pm nor I will lodge a FIR against him and Mohan. I got a call from Manoj at 9pm, and said that he would only come home if I transfer him 2000rs, I requested him I have 500rs in account and transferred him. Atlast He came home at 12pm.

All of these incident was said to his parents and his relatives but none paid attention to it and supported Manoj to the uttermost they could and still. Things passed by and I was helpless because I don't belong from a strong background and I have no parents. Still my sister was on back of me for any of my emergencies. My husband nor used to give me a penny from his salary but just used to pay rent. All my expenses from top to bottom and even his I used to bear.

Days passed on August my father in laws had a operation for prostate ,I was not informed nor involved .They themselves admitted him and manoj and his mother both started residing in salugara forest quarter with my father in law brother Mr Kazli Chhetri who is posted as forest ranger in Salugara region .Nor my husband nor his mother came or notified me about his condition. But still one of the nursing staff Richa Rai helped me to meet my father in law during non visiting hours. On my visit to my father in law in that quarter after his operational discharge everyone along with manoj and mother in law didn't allow me and my sister sunila to enter or sit and talk . Still however we convinced and saw him and came back. I was alone at my rent house for 15 days ,later when I called manoj he again started not lifting my call not even his mother. so I messaged him about paying the rent .He denied of paying and saying that he has given resignation. Without my concern he resigned his job sand went home. I called his mother, father and him but none of them lifted my call.

On eve of Dussera (14 October 2021) my husband called me all of a sudden and requested me to join and come for puja .It was my night off so he came to receive me on his car and drove me from Siliguri to hamiltonganj. When I reached his home I met my father in laws had a chat and gave him a symbol of love for festival 5000rs in his hand in presence of our maid Bishnu . I was just carrying my luggage and entering the room ,my mother in law said me to rest in a room where a maid rest. Now it became a matter of self respect and I lost my patience and quietly slept and decided to go home early morning. but unfortunately again my father in law health was detoriated and was taken to Siliguri. Every single one of them went home leaving me and maid alone. I still was in home. On evening my mother in law called the maid and said him to inform me to not to enter kitchen nor any room nor touch the car key and go where ever I want because they think iam the reason to detoriate my father in law health condition, without a second thought on 16th October I came back Siliguri alone. Sucidal thoughts and depression became a key I stopped going my duties but my family used to consult with a psychiatrist for my mental depression at a such young age. I had tried killing myself from a high point but as on point of time I tried to gain hope.

Month passed by again no calls nor messages by my husband he was roamimg around with his friends at his native. So I planned to go on November to see my father in law where my mother in law and her sister Mrs Kokila Chhetri resident of Birpara starting abusing me and refarning from meeting my father in law. They started blaming me for my father in law's ill health condiition. Mrs Kokila chhetri started to cousell me to give divorce to manoj as soon as possible without asking a single money. I somehow gained courage and said you people are no one to decide my fate I will decide my own to stay or leave Manoj. After saying this I left to junction and took train and came back Siliguri.

On December ,again I called Manoj saying that I cant stay alone in this rent house. He said he will come soon and shift me to other place . After few days he came and said me to shift in my parents home as he wont be able to pay rent and he would visit me frequently on Saturday and Sunday. I was ok with it and I shifted to my parents home. As a wedding gift I had recived many electronic so he said he will take mixer ,oven and gold ring and chain with him worth (RS 1.5lakhs). And I agreed to it and gave him along with his Tv and Homethearter. He went home again and yet again didn't call nor texted me. I was fed up I would call him ,cry and beg for a good future . But he would always ignore my calls even his parents.

So I requested him to come my home and meet me as it was more than a month. He said YES. 25TH JANUARY, he came to meet me at my home. Next day he requested me to come to a hotel named tourist in near P.C. MITTAL BUS TERMINAL, he said a party is being organised by my friend Amit Yadav working in KOTAK bank for his pre wedding. I asked him if any of his friends wives are going because it will be awkward for me as a woman in front of man based party. He said yes their wives were also invited. So I informed my sister and went in my scooty. At 8pm I reached there, two men were brought in the room named amit and ram, they smiled and said hello I greeted them too. I felt quite awkward in the situation. My husband manoj said me around 10 pm I was having dinner saying, he would go to a room and come back soon so he locked me from outside. It was late 11:30 pm so I slept. At 3am I heard someone knocking the door frequently. When I woke up I saw manoj wasn't there. I got scared and said who is it. There was no reply but a forceful intention of opening the door. I held the door so that it doesn't open. I screamed manoj name and called on his phone several times more than 100 times. Still he didn't pick up my call. Then around 3:30 am I got a call at the hotel landline in the room I was in when I received the person started threatening me of rape and murder and to open the door. I was scared so cut down the call still again calls and calls were coming on landline. Simultaneously I was calling manoj too. 4am a sudden thrash and the room door opens I just got so scared and I saw manoj with two same friends amit and ram full drunk and started holding my neck and blushing my face I somehow was ready with my bag took it and ran downstairs to manager. But there was no manager where I could complaint. I went to a security who was in the exit gate, he wasn't allowing me to go but as I was crying and showed him my service identity card. I took my scooty and 4:30am I was out of the hotel premises and went to a hospital I work took a TT injection because that midnight I got some cuts on my hands and knees while driving I lost balance and fall near Desun hospital. And then went home around 6am. I was shocked and shattered I didn't even have a courage to go and FIR the situation because since 2 years I'm not in a good mental stage as he has always violence me physically, mentally, socially and financially.

Till today (8/05/2022) he has neither contacted me nor his family. I called him to give my expenses but rather as soon as I call him, I get threatening calls from unknown numbers. I went to lawyers for help but due to heavy demands by lawyers I'm helpless and financially weak. I am the only breadwinner of the family now as I have to see my sister and her child expenses because her husband is unemployed. I am in seek of justice Madam. I came across through Respected Mamta Begam madam through a NGOs as I believe you would provide me justice for a better living.

Looking forward for your earliest cooperation.
