Sir,

In producing herewith two (02) arrested accused namely 1. Sarafat Hussain (35) S/O Tafil Hussain of Putimari, Dangapara, P.O- Balaram, P.S- NJP, Dist- Jalpaiguri and 2. Safikul Islam (27) S/O Ajab Ali of Bayachari, P.O- Bayachari, P.S- Rajganj, Dist.- Jalpaiguri along with the following articles under seizure as per seizure list:

- i) One TATA ACE vehicle having Registration No. WB 73C 1903 loaded with total 03 (three) numbers of black colour cattle (buffaloes) of different size.

I, SI Newton Biswas, S/O- Nirmal Biswas of New Jalpaiguri Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted accused persons to the effect that on 08.05.2022 at about 17.35 hrs I received a specific source input that huge numbers of stolen cattle were being transported in one TATA ACE vehicle bearing no WB 73C 1903 through Murder More towards Jalpaiguri. If the information would not be pursued immediately, those cattles would have been concealed in any secret place by this day. The matter was diarized in New Jalpaiguri PS GDE No. 374 Dt- 08.05.2022 and also informing the matter to the Officer-In- Charge, New Jalpaiguri Police Station and being directed, I along with HG/794 Ranjit Roy, VP /08 Laxman Roy, VP/ 13 Jamirul Islam and CV/ 116 Rohit Kumar Mahato all belongs to New Jalpaiguri Police Station left for Murder More under PS- NJP by Govt. vehicle to verify the veracity of the information.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Murder More under New Jalpaiguri Police Station at 17.50 hrs and called two independent witnesses namely 1. Nitai Sarkar S/O Ganesh Sarkar of Thakurnagar Colony, P.S- NJP, Dist.- Jalpaiguri and 2. Nirmal Saha (32) S/O Shyamal Saha of Ambika Nagar, Road No. 02, P.S- NJP, Dist.- Jalpaiguri and after disclosing our identity we disclosed the purpose and requested them to accompany with us as independent witness. As they agreed and we along with two witnesses started waiting there at the said area looking for TATA ACE vehicle bearing no WB 73C 1903 loaded with cattles. Just few minutes later, we saw one TATA ACE vehicle bearing no WB 73C 1903 coming towards us from Chunavati side. Immediately we prepared ourselves and intercepted the the TATA ACE vehicle having Registration No. WB 73C 1903 loaded with 03 (three) cattle (black colour buffaloes). The above noted Safikul Islam was driving the vehicle and the above noted Sarafat Hussain was found sitting beside driver seat of the said vehicle. They are carrying or transporting cattle (buffaloes) in a congested space in such a manner as to subject them pain or suffering. On demand none of the accd. persons were unable to produce any document or any satisfactory account for possessing the cattle (black colour buffaloes) at the vehicle. They also failed to produce any document in respect of said cattle and said vehicle including the permit to carry live stock. Thus it has been made crystal clear and can reasonably be believed that the above noted accd. Persons had procured the cattle by any illegal means or by means of theft.

During interrogation accused Persons disclosed their identity as mentioned above and admitted their guilt and stated that they deal in stolen cattle and dispose off the same by illegal means for their wrongful gain.
