Sir,

In producing herewith one accused person namely Narayan Ghosh (50) S/O Lt. Sachin Ghosh of Bhaktinagar Pipe Line, P.S- NJP, Dist.- Jalpaiguri along with seized articles viz.,

1] Total 17 (Seventeen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 10.2 liters, value Rs.120X17=2040/-), and marked as 'exhibit -A'

I, PSI Newton Biswas presently posted at New Jalpaiguri Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted person that today (13.05.2022) at 09.55 hrs. myself along with officer and forces of NJP P.S, SPC left P.S for special raid duty vide NJP P.S GDE No. 606 Dtd. 13.05.2022. On the way I receive a specific source information that one person namely Narayan Ghosh (50) S/O Lt. Sachin Ghosh of Bhaktinagar Pipe Line, P.S- NJP, Dist.- Jalpaiguri has stored huge quantity of illegal liquor at his house without any valid license. Acting on source information, myself along with ASI Sajal Das, HG/794 Ranjit Roy and VP /08 Laxman Roy all of New Jalpaiguri PS, Siliguri Police Commissionerate had been to the house of the accused namely Narayan Ghosh at Bhaktinagar Pipe Line area and found that the aforesaid person had been selling illegal liquor to the common customers at his house at Bhaktinagar Pipe Line area under NJP PS. Then I cordoned the place with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he used to sell illegal liquor at this place for his wrongful gain since very long. On being search of him in presence of available witnesses the above noted seized articles are found inside a bag from his conscious possession. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list and presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place, the persons who were having liquor at that place manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 13.05 hrs. to 13.35 hrs.

Therefore, I pray before your good self that a specific case against the above noted accused person namely Narayan Ghosh (50) S/O Lt. Sachin Ghosh of Bhaktinagar Pipe Line, P.S- NJP, Dist.- Jalpaiguri may kindly be initiated under proper section of law and may cause for its investigation.
