In producing herewith one male accused person namely Raju Sahani (40yrs.),S/O Lt. Bishnudeb Sahani,of Ganganagar near Vendikhet ,W/No-05,PS-Siliguri,Dist-Darjeeling along with the following seized articles as per proper seizer list.

1.15(Fifteen) bottles of Himalaya Gold 60up premium country spirit ( each bottles containing 600ml. & MRP Rs 120/-)

I ASI Samiran Das of Khalpara TOP under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 13.05.2022 at 07:55 hrs. received an information from Ganganagar near Vendikhet,W/NO-05,PS-Siliguri,Dist-Darjeeling that one person has gathered huge quantity of illegal liquor which was kept in his house in one gunny bag for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO - 269 /22, Dated-13.05.2022. As per your kind instruction myself along with ASI Sanjay Hasda C/174 Pradip, CVF 980 Ranjan Ojha and proceeded to the PO to work out the information . At 08:25 hrs. we reached at the Ganganagar near Vendikhet,W/NO-05 ,sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. he become nervous and admitted his guilt before us and stated that he sell same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample.

(The seizure was made in between 08:35hrs. to 09:25hrs.) I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Raju Sahani (40yrs.),S/O Lt. Bishnudeb Sahani,of Ganganagar near Vendikhet ,W/No-05,PS-Siliguri,Dist-Darjeeling under proper section of law and arrange for investigation .
