I.D.E no- 423 dtd 02/01, Sri Ashok Kumar Jaiswal, son of Late Murlidhar Jaiswal, Director of Tripti
and Started M.P.G. & Co. Dealers Private Limited, having its office at Station Feeder Road, Siliguri, P.O.
09/05/22 D/S- 465/467 & P.S.- Siliguri, Dist. Darjeeling, am to write to you that a number of criminal
cases have been initiated against Sri Shambhu Bhagat, Shankar Bhagat, Ajay
Bhagat, Biswanath Bhagat, and Santosh Chowdhury, Bijay Bhagat and Atok
Biswas on account of a massive criminal conspiracy having been
accomplished by them in forging the volume records kept with the office of the
District Registrar at Darjeeling and manufacturing forged certified copies of
certain deeds namely I-2223 for the year 1957, I-283 for the year 1962, I-284
for the year 1962, I-265 for the year 1962 and I-286 for the year 1962 and
consequently attempting to grab the lands belonging to our company at
Mouza- Tumba, Police Station- Matigara, District- Darjeeling.

Please take note that Sambhu Bhagat has placed the copies of the aforesaid
forged deeds before the Land Reforms office and got his name recorded with
regard to the entire land in L.R. Plot no. 1540 at Mouza- Tumba, Police
Station- Matigara, District- Darjeeling measuring 0.30 Acre, which previously
existed in the name of our company, i.e. Tripti Dealers Private Limited in L.R.
Khatian no. 4640 of Mouza- Tumba, Police Station- Matigara, District-
Darjeeling.

Please take further note that Sambhu Bhagat (after getting his name recorded
in the record of rights as aforesaid) has also illegally transferred the land
measuring 4.79 Decimals in L.R. Plot no. 1540 at Mouza- Tumba, Police
Station- Matigara, District- Darjeeling to and in favour of one Kameshwar

Jaiswal, son of Swaroop Lal Jaiswal, resident of Flat no. 203, Tower no. 5, MIG Apartments, Uttarayon, Matigara, Post Office and Police Station- Matigara, District- Darjeeling, Pin- 734010 vide a Deed of Conveyance being no. I- 3356 for the year 2020 registered at the office of the Additional District Sub Registrar at Bagdogra.

Sir, the aforesaid L.R. Plot no. 1540 is the subject matter of Title Suit no. 187 of 2021 initiated by us in the court of the Learned Civil Judge (Junior Division) at Siliguri against said Sri Kameshwar Jaiswal and Sambhu Bhagat.

Sir, Kameshwar Jaiswal is proceeding with construction works in and over the aforesaid land measuring 4.79 Decimals at L.R. Plot no. 1540 at Mouza- Tumba, Police Station- Matigara, District- Darjeeling in spite of our repeated obstructions and reminders to him that the said works being carried out by him are illegal.

In the circumstances, your are therefore requested to immediately look into the matter and take necessary steps to stop the said illegal construction works, failing which immense damage shall be caused to us.
