Sir,

In producing herewith one accused named Bidhan Modak (24) S/O- Binoy Modak of Chandamari, P.O- Putimari, Fuleshwari, P.S- Kotwali, Dist- Coochbehar A/P C/O- Ramesh Roy Bottle Company, P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure'

1] 15 (Fifteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 9 liters, each bottle value Rs 100/-) and marked as "exhibit A" in which One bottle Himalayan Gold 60 UP Country Spirit taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1"

I, ASI Nitai Mandal of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one named Bidhan Modak (24) to the effect that today on 15/05/2022 at 18.10 hrs while performing evening patrolling duty, at about 20.05 hrs received a source information that one person named Bidhan Modak (24) is selling liquor to their designed customer in near Bottle company, under Bhaktinagar PS without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with C/986 Rajib Sarkar, CV-014 Labanyamay Barman had been to Bottle company under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing at his rented house. Subsequently, I along with my force cordoned the residence and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the tenant of the house. Further being searched the above noted seized articles were found in the said residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Bidhan Modak (24) S/O- Binoy Modak of Chandamari, P.O- Putimari, Fuleshwari, P.S- Kotwali, Dist- Coochbehar A/P C/O- Ramesh Roy Bottle Company, P.S- Bhaktinagar, Dist- Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:20 hrs to 20:40 hrs at the spot and arrest issued memo of arrest at 20:42 hrs against him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Bidhan Modak (24) S/O- Binoy Modak of Chandamari, P.O- Putimari, Fuleshwari, P.S- Kotwali, Dist- Coochbehar A/P C/O- Ramesh Roy Bottle Company, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
