In producing herewith the three (03) accused person namely (1) Rabi Biswakarma (32) S/O Late Swapan Biswakarma of Botal Company Jyotonagar PS Bhaktinagar Dist. Jalpaiguri (2) Gadai Biswas (45) S/O Bibhuti Bhushan Biswas of Hyderpara Sarat Chandra Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri and (3) Bijay Roy (35) S/O Sadhu Roy of do in custody arrested and the following property weighing total 815

(1)One packet said to be Brown Sugar wrapped with brown coloured cello tap weighing grms said to be Brown Sugar under seizure:-265 grms approx recovered from the possession accused Rabi Biswakarma (32) S/O Late Swapan Biswakarma of Botal Company Jyotonagar PS Bhaktinagar Dist. Jalpaiguri which he kept conceal inside the right side pocket of his full pant ,Marked as exhibit - " A"

1, S.I Swapan Ghosh of Ashighar Out Post PS Bhaktinagar SPC do here by lodge this complaint to the effect that on 15.05.2022 at 19.05 hrs received a secret source information that three persons are standing at, Baneshwar More, Ashighar and they are possess huge quantity of Brown Sugar with a view to sale the same in Siliguri area and its adjoining area and they could be caught red handed, if apprehended immediately. Accordingly I diarised the matter vide ASG OP G.D.E No. 345 Dated-15.05.2022 and informed the matter to O/C Ashighar OP and as per his instruction myself along with SI Paramartha Barma, ASI. Inzamamul Hoque, ASI Amit Mallick, C/877 Munna Ahmed and C/376 Shymal Choudhury left for Baneshwar more area in a Govt vehicle along with weighing machine & investigation kit at 19.15 hrs to verify the veracity of the information vide ASG OP GDE No. 348 Dt.15.05.2022. On way to Baneshwar More I called two independent witnesses namely (i) Sujit Roy (31) S/OLate Satish Roy of Telipara Ashighar PS Bhaktinagar Dist. Jalpaiguri and (ii) Jagobandhu Barman (25) S/O Late Anil Barman of Ambari Falakata, Near Chakiavita High School PS New Jalpaiguri Dist. Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 19.35 hrs on arrival there as identified by the source we surrounded three persons standing at Baneshwar More. On being asked they disclosed their identify as noted above. I informed them about the information in hand and they will be search. After disclosing our identity I asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and they agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provisions of law in this regard. Then I requested Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC over R.T to appear at the spot and remain present as gazetted officer. After some times at about 20.05 hrs Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC arrived at the spot. I narrated the whole fact to him disclosed the identity of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC to the accused persons as gazetted officer. Under supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC the above noted accused persons were searched keeping strict regard of

their decency and recovered three numbers of packets of said to be Brown Sugar wrapped with brown coloured cellotape which they were kept conceal inside the pockets of their full pants. They confessed in presence of Gazetted Officer and other witnesses that they procured the said Brown Sugar clandestinely from Nadia and other area for the purpose of its selling to the local youths of Siliguri and the adjacent area with a view to earn huge money quickly. On being asked they failed to produce any documents or license in support of their such possession. Then as per direction of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC I weighted the said packets of said to be Brown Sugar with weighing instrument which was kept with us and found the weight of recovered said to be Brown Sugar packets are (i) 265 Grms approx, (ii) 290 Grms approx (iii) 260 Grms approx respectively, total weight 815 Grams Then I packed, labeled and sealed the three numbers of recovered Brown Sugar packets in presence of witnesses, and seized all the recovered articles under proper seizure list under the supervision of Shri Amaresh Singh, Inspector Incharge Bhaktinager Police Station, SPC duly signed by the local witnesses and the accused persons. The seizure was made in between 21.05 hrs to 21.35 hrs. Then I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest. The copy of seizure list and memo of arrest have been supplied to the above noted accused person under receipt. Thus the accused persons violated the terms and condition of N.D.P.S Act. for possessing Brown Sugar without any authority.

Under the above circumstances, I pray to you that a specific case under NDPS Act may kindly be started against the accused person namely (1) Rabi Biswakarma (32) S/O Late Swapan Biswakarma of Botal Company Jyotònagar PS Bhaktinagar Dist. Jalpaiguri (2) Gadai Biswas (45) S/O Bibhuti Bhushan Biswas of Hyderpara Sarat Chandra Pally W/no. 40 PS Bhaktinagar Dist Jalpaiguri and (3) Bijay Roy (35) S/O Sadhu Roy of do and arrange for its investigation.
