Respected Sir,

With due respect this is to inform you that I Sri Nand lal Roy, S/o Moti lal Roy, Dist – Darjeeling. purchased a plot of land along with my cusion brother namely Janardhan Roy from one Shiv Nath Prasad and Binod Prasad both are S/o late Ramayan Prasad, R/o Kathar Bagan Church Road Siliguri by virtue of Registered Deed of Sale on 28/02/2006 and it was duly registered before the ADSR Bagdogra and after such purchase myself and my brother Janardhan became the owner of the said land measuring 2 kattha 8 chatta situated at Mouja Mallaguri, Paraghana - Patthar ghatta, J.L No. 107, Plot No. 103 recorded in khatian No. 61/4 Sub Division Siliguri ADSR Bagdogra, P.S Pradhan Nagar Dist – Darjeeling and we were jointly holding and possessing the above mentioned land without any encumbrance whatsoever. It is pertinent to mention that said Janardhan Roy is my own cusion brother.

Sir I am employee of M/s Sri Radha Ballavabh Roadways a Transport Company situated at K.C Dey Road Siliguri and for my nature of work I always used to stay out of Siliguri and most of the time I used to reside at Kolkata and Assam.

That few days back I came to know that someone has constructed a structure on our land. Having heard the said fact, on 08/05/2022 I rushed to the land and found that some stranger has constructed a Tin Shed construction and is residing there. On being asked, they said that they purchased the land from Janardhan Roy and Nand lal Roy. After hearing the same, I became astonished. I have never sold the land to them by virtue of any Registered Deed of Sale although they don't know I am Nanda Lal Roy. Thereafter I had been to ADSR

Bagdogra and obtained the certified copy of the alleged sale deed where I found that someone Nand lal Roy, along with my brother and allegedly sold that land in their favour being Deed No.10227 for the year 2014 and said fake deed was duly registered to ADSR Bagdogra Siliguri. Although during that period I was at Kolkata for job purpose and I never attended the Registry Office and never signed and executed any sale deed to anybody till date. And all the false transaction made by my cusion brother with the help of anti social land mafia making conspiracy with one Surendar Sah S/o Ram Dew Saha of Champasari who became the witnesses of the said false Sale deed.

Sir I was employee of Transport Company and most of time I was out of Siliguri due to my job purpose and my cusion brother taking that advantage of my absence he sold out my purchased land to Sandhya Devi and Lovely Prasad with the help of Raju kumar and Ranjit Kumar who are involved in the land transaction and they are habitual land mafia.

Sir, Janardhan Roy along with Raju Kumar and Ranjit Kumar prepare the false deed which was not executed by me and from the alleged Registered Sale Deed it will also be revealed that the photo fixed in the deed is not my photograph.

I am enclosing herewith the copy of the said false deed for your ready reference.

You are therefore, requested to enquire into the matter and to take appropriate legal action against them
