With due respect, I Mrs. Pinki Singh, wife of Mr. Raju Singh, Resident of Jyoti Villa, No. 1 Dabgram, near Surya Nagar, Football Play Ground, Ward No 23 of Siliguri Municipal Corporation, P.O. Rabindra Sarani, P.S. Siliguri, District-Darjeeling, Pin Code- 734006, would like to inform you that since last 5 year I am residing separately from my husband with my two children in separate flat situates at above stated address.

That one person namely Md Khatibul Haque, resident of Himal Shahid Nagar, Najrul Path, Ward No. 43, P.O. Bhaktinagar, Dist-Jalpaiguri, was/ is a friend of my brother-in-law and he was also a business partner of my said brother-in-law and as such I came to know him through my in-laws. The said Md Khatibul Haque had been an accused in some criminal case and his bank account got seized for that reason. Then after he requested me for favor to provide him my bank account so that he can do all his business transaction through my bank account and in good faith I provided him my bank account and he has been using my said bank account for three years for his business purpose. That the said Md Khatibul Haque use to come in my resident to take my signatures and some time to collect the money as many times it happened that I have withdrawal his money from ATM or Bank.

That somewhere in the year 2020, he said that he likes me and want to marry me but immediately I refused him and the said Md Khatibul Haque is married having three children, after my refusal he started blackmailing me by cutting his hands or poisoning himself and regarding this incident I have informed his wife and father. And also, I came to know from my friends that he made a forged certificate of religion convert in my name of and he tells everybody that I am his wife and I converted my religion to Muslim for the sake of marriage.

That on 14/05/2022, at about 7:00 P.M. I have gone to the house of School's Principal namely Mr Pallab Chakroborty of my children to pay the tuition fees of my children and on the way i.e., No. 2 Dabgram Santinagar (Middle), near Xavier's International School Siliguri, I saw that said Md Khatibul Haque was coming towards me, again he said that he still likes me and I refused him as before, he got furious and stortion a specific started beating me and squeezed my neck in the public place, some people came and rescued me from his hand, he has also threatened me by saying that he will throw acid on my face in future. I got injured and on 15/05/2022 I treated myself in the civil hospital and now I am under medication.

Therefore, due to assault I was in rest for whole day and as such, I could not lodge my written Complaint yesterday, so I am requesting you to accept this written complaint and take appropriate level action serious serious. complaint and take appropriate legal action against the said Md Khatibul Haque for OFFICER IN CHARPhysical abuse and making said fake document and claiming me that I am his wife.
