In producing herewith one accused person namely Sushil Mondal(56yrs) S/O-Lt. Sitaram Mandal of Santoshinagar, Machlimore, Ward No-5, PS-Siliguri, Dist-Darjeeling along with seized 12 (Twelve) bottles of Himalayan Gold 60 up country spirit containing 600 ml. each , total value Rs- 1440/- (Rupees One Thousand Three hundred and sixty). In whish 1(one) bottle taken as sample and marked as exhibits A-

I, ASI Samiran Das of Khalpara TOP under Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person that on 21.05.2022 at 07.55 hrs vide GDE No- 500 received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his house at Santoshinagar, Near Ram Janki Mandir, Ward No-5, PS-Siliguri, Dist-Darjeeling in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Siliguri PS. As per his direction I along with ASI Sanjay Hasda, C/-239 Badal Kr Barman, CV/005- Gobinda Roy left for Burdwan Road, near Santoshinagar more, Ward No-5, PS-Siliguri to verify the veracity of the information. On reaching there and as identified by source cordoned his house where he kept illegal illicit liquor. On arriving there found the above noted person who disclosed his identity as noted above and on search found huge numbers of Himalayan Gold country made spirit containing 600 ml. each at his house in conceals position. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since long time for wrongful gain.

Accordingly I seized the same in presence of witness as per proper seizure list duly signed by the witnesses. The seizure was made in between 08.15 hrs and 80.45 hrs. On being asked he stated that he kept the same with a view to sale without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accused namely Sushil Mondal(56yrs) S/O- Lt. Sitaram Mandal of Santoshinagar, Machlimore, Ward No-5, PS-Siliguri, Dist-Darjeeling as per proper section of law.
