On arrival at Bidhan road near Gosto Paul More at 08:25 hrs being pointed or source, found that one person is proceeding with huge quantity of country spirit containing with a Nylc n intercepted the said accused person with loaded articles in presence of witnesses. During interroga accused failed to produce any documents/license in support of the same and stated that he will sale the the land petition of traperkote adjacent area illegally with a view to earn huge money for his live to be to the proof the said person with loaded articles in presence of witnesses. On search I re-(i) 10 (ten) Boules of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml ea packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL No

On interrogation he failed to produce any valid documents/license in support of the same and stage he sailed the same to the local people illegally with a view to earn huge money for his lively hood. According I seized (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 when packed, MRPRs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized article (i) under proper seizure list and labeled the same in presence of witnesses and duly sign by them and al accused person and arrested him. The seizure was made between 08:45 hrs to 09:15 hrs and arrested the person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1200/-

Under the above circumstances I am submitting this written complaint against the above accus namely Buddha Gurung (M/58) S/O- Lt.
