In producing here with the one arrested accused person namely Subodh Das (37 yrs) S/o Mehen Das of Halalpur, Near Durga Mandir, P.O - Runia, PS- Raiganj, Dist- Uttar Dinajpur along with the following seized articles as per proper seizure list:

1] Ten (10) Bottles of Himalayan Gold Country Spirit 60 UP each bottle containing 600 ml.

I. ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 25.05.2022 at about 20.05 hrs received a source information that the above noted accused person has possessed huge amount of liquor in his local shop style as Baba Hotel at Biswanath More under Bhaktinagar PS for selling the same to local customers. This refers to Bhaktinagar PS GDE No. 1406 Date. 25/05/22. Accordingly the information shared before you and as per your kind direction I along with ASI Nitai Mandal, C/ 986 Rajib Sarkar, CVF/ 935 Biplab Roy, CVF/619 Dharmendra Barman of Bhaktinagar PS left PS to work out the information. At about 20.20 Hrs we reached at Baba Hotel, Biswanath more and as shown and being identified by the source held raid at the aforesaoid shop and apprehend one person who disclosed his name and address as noted above. Further maintaining his decency and observing all formalities searched inside the shop and recovered huge amount of above noted seized liquor. On demand of license and documents in respect of possessing the liquor he failed to produce the same. On enquiry the apprehended accused person admitted his guilt and confessed that he has possessed above noted liquor for the purpose of selling to his designed customers for his wrongful gain. He also stated that he has been doing this act illegally since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 20.45 to 21.20 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Subodh Das (37 yrs) S/o Mehen Das of Halalpur, Near Durga Mandir, P.O- Runia, PS- Raiganj, Dist- Uttar Dinajpur under proper section of law and arrange for its investigation.
