With due respect and producing herewith arrested accused person namely Goutam Saha s/o Lt. Narayan Chandra Saha of NJP Bhaktinagar, Ward No.- 34, PS-NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated by them. :-

1. 02 Khaki Color Bags style as Government of Punjab containing 50 Kg of FCI Rice in each bags.

2. 02 white Color Bags style as Bakery Maida containing 50 Kg FCl Rice in each bags.

- 3. 02 Red and White Color Bags style as Maida, Bakery Maida. containing 50 Kg. FCI Rice in each
- 4. 01 Red and White Check Color Bags style as DEVI MARKA Containing 50 Kg of FCI Rice.

5. 01 Red and White Color Bag containing 50 Kg. of FCI Rice.

6. 03 khaki Color empty Bags style as Government of Punjab, Manufatured in Inida.

I, PSI-Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to report that on 23.05.2022 at 2345 hrs I received an information that one person namely Goutam Saha s/o Lt. Narayan Chandra Saha of NJP Bhaktinagar, Ward No.- 34, PS-NJP, Dist.- Jalpaiguri is selling and store huge quanity of Stolen Rice supplied by FCI [Food Corporation of Inida] . Accordingly I informed the fact to the Officer-In-Charge, NJP PS and diarized the fact in General diary vide NJP PS GDE No.1162 dtd.23.05.2022. Accordinly as per your kind order myself along with SI Samik Paul, VP/08 Laxman Roy, VP/13 Jamirul Islam , CV/306 Biswajit Roy & HG/794 Ranjit Roy all of NJP PS left for NJP Bhaktinagar, Ward No.- 34, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 0015 hrs dated: 24.05.2022 we arrived at NJP Bhaktinagar, Ward No.- 34, and held raid at the house of Goutam Saha s/o Lt. Narayan Chandra Saha of NJP Bhaktinagar, Ward No.- 34, PS-NJP, Dist.- Jalpaiguri and apprended the accused person and on being asked he disclosed his name and address as noted above. After prolong interrogation he admit his guilt that he is involved in such crime since very long for his wrongfull gain. Accordingly, I, searched the house and found total 08 different bags of Stolen Rice supplied by PDS of FCI Rice containing 50 Kg in each bag [Total 400 kg] and 03 empty bags written as Government of Punjab. On demnand he failed to produce any documents in respect of the said Rice. After thorough interrogation he admitted his guilt and disclosed he has purchase the Governement rice Food Corporation of India [FCI] distributed by PDS illegally for his wroingful gain. There was sufficcient reason to belive that the Rice is stolen. Accordingly, I seized the said vehicle under proper seizure list and arrested the above noted accused persons under proper memo of arrest and observing all the formalities of arrest and brought to NJP PS. There search seaizure was made in between 01.15 hrs to 01.40 hrs on 24.05.2022

Under the above noted fact and circumstances, I therefore pray before you that a specific case under proper section of law may kindly be initiated against the accused person namely Goutam Saha s/o Lt. Narayan Chandra Saha of NJP Bhaktinagar, Ward No.- 34, PS-NJP, Dist.- Jalpaiguri and arrange
