I, ASI Sajal Das of New Jalpaiguri PS, Siliguri Police Commissionerate beg to state that on 23.05.2022 at 23.35 hrs I received a secret source information that a gang of miscreants come to Back side of Housing Ground, Jabravita, near Mandir, Thakur Nagar under PS-NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Baribhasa area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East –II, SPC and diarized the fact in General diary vide NJP PS GDE No 1161 dated 23.05.2022. As per kind order and direction of my superior officer myself along with, VP/13 Jamirul Islam, CV/306 Bisawajit Roy and CV/846 Rohit Mahato left for Thakur Nagar Colony to work out the information in hand. I also informed the fact to night RT Van officer ASI Bhai Chadra Tamang and directed him to come to to accompany with us. At about 00:15 hrs on 24.05.2022 we arrived at near Thakurnagar, Housing Grond under PS- NJP, Dist.- Jalpaiguri. After a few time ASI ASI Bhai Chandra along with force came there and accompany with us. At about 01:25 hrs we found that 11/12 persons assembled in a dark place at Back side of Housaing Ground, jabravita, and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 07 (Seven) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and give different statement in different time and finally they disclosed that they assembled there to commit dacoity at Thakurnagar, Baribhasa area.

On search of the apprehended accused persons, I found one iron made sharp cutting weapons called as Bhojali and one sharp cutting knife from the possession of accused Khokan Adhikary s/o Nipen Adhikary of Madani Bazar, PS-NJP, Dist.- Jalpaiguri, one sharp cutting knife and one plastic made charger torch light and from the possession of accused Bisu Mandal s/o Nur Singh Mandal of Dakshin Shantinagar, PS- NJP, Dist.- Jalpaiguri and one iron made Hasua and one iron made sabol from the possession of accused Krishna Das s/o Narayan Das of Dakshin Shantinagar, PS-NJP, Dist.- Jalpaiguri. One Iron Rod from the Possession of Narayan Das s/o Tarapada Das of Dakshin Shantinagar, PS- NJP, Dist-Jalpaiguri, One bamboo made lathi and one charge tourch light from the possession of Babun Sutradhar s/o Sunil Sutradhar of South Shantinagar, PS- NJP, Dist.- Jalpaiguri, One screw driver with pointed and sharp cutting knife from the possession of Tapan Barman s/o Dakshina Barman of Kamakpara, Baribhasa, PS- NJP, Dist.- Jalpaiguri, and One iron made swoard measuring 50 cm in length from the possession of Aminul Islam @ Kundu s/o lt. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in a dark place. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity at Baribhasa, Thakurnagar area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 07 (Seven) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 01.15 hrs and 01.40 hrs on 24.05.2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (1) Khokan Adhikary s/o Nipen Adhikary of Madani Bazar, PS-NJP, Dist.- Jalpaiguri (2) Bisu Mandal s/o Nur Singh Mandal of Dakshin Shantinagar, PS- NJP, Dist.- Jalpaiguri (3) Krishna Das s/o Narayan Das of Dakshin Shantinagar, PS-NJP, Dist.- Jalpaiguri (4) Narayan Das s/o Tarapada Das of Dakshin Shantinagar, PS-NJP, Dist.- Jalpaiguri (5) Babun Sutradhar s/o Sunil Sutradhar of South Shantinagar, PS- NJP, Dist.-Jalpaiguri (6) Tapan Barman s/o Dakshina Barman of Kamakpara, Baribhasa, PS- NJP, Dist.- Jalpaiguri (7) Aminul Islam @ Kundu s/o lt.
