Respected Sir,

With due respect I Smt. Munni sarkar, W/o Rony Saha @ Rakesh Saha, presently residing at Pran Krishna Colony, in the house of Raju Singh on a rent at Tikia Para, ward no- 28, Dist. Darjeeling, would like to draw your kind attention to the following effect that our marriage was solemnized of 11.12.2009 at Sevok, Kali Bari out of love affair thereafter my husband brought me at Babuihathi, Kolkata in his parental house and after eight months my husband took me in Siliguri in a rented house at Deshbandhu para and he used to work in a restaurant as cook and due to our wed lock two children were blessed one female and one male accordingly they are in class 6 and class 1 in Govt School. It is pertinent to mention that after two years of our marriage my husband used to torture physically and mentally upon me due to want of dowry. My father is ill since long he is also passing his days in financial crisis not possible for him to financially support me for which my husband also hurling filthy languages towards me and he do not provide me and my children proper food, cloth and medicine and also denied to incur educational expenses in respect of our children. Due to public disgrace I did not lodged any complaint against my husband and I also thought good sense will be prevail upon him and he will understand me. However four years ago my husband mercilessly beaten me and also drove me from our rented house at Deshbandhu Para that on 11.05.2022 at about 9:00 pm with a drunken condition mercilessly beaten me due to want of Rs- 20,000/- and directed me to bring the same from my parents or relatives but I denied and somehow I fled from house but he chase me with a bottom by saying that he will kill me and due to fear our children also fled with me and now I took shelter in my elder sister's house at Jabrabita, Near Hanuman Mandir, Bari Bhasa. My husband used to call me through his cell phone with threat and also sent voice messages with dirty languages (9641540992). That due to mental hazard some unintentional delay is occurred to lodged this complaint.

In view of above you are requested to take proper legal step against the aforesaid person as per law.
