Sub: -F.I.R. against my Husband Sri Samar Saha and his family members for the offences of committing Cruelty upon me and my children, Theft, Criminal Breach of Trust & Intimidation.

Respected Sir,

With due regards, I, **SMT. MITHU SAHA**, Wife of Sri Samar Saha, Daughter of Sri Raj Kumar Das, Presently residing at Subhash Nagar Colony, Kabi Guru Sarani, Subhash Pally, Ward No. 19 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that **SRI SAMAR SAHA**, Son of Late Amalya Kumar Saha, Resident of Rathkhola, Near Ganada Sundari Library, Ward No. 22 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, is my legally married husband and our marriage was solemnized on 28.11.2004, according to the Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house as mentioned aforesaid. At the time of my marriage, my parents and other family members have given so many valuable articles like Golden Ornaments, Furniture & Fixtures, one Scooter, Utensils, Clothing's and other valuables including cash a sum of Rs. 20,000/- only as per the demand of my husband and his family members. After my marriage, my husband brought me at my matrimonial house as mentioned aforesaid where we have started to live and co-habited together as husband and wife and in my matrimonial house, besides me and my husband, my Mother-In-Law namely Smt. Papia Saha and eight Brother-In-Laws and their respective family members have also resided there. Sir, just after entering into my matrimonial house, my Mother-In-Law asked me to handover all my golden jewelries and other valuables which are "Stridhan" in her favour and as per her direction, I have handed over all my jewelries and other valuables to her and since then, all my Stridhan Properties are under the custody of the Mother-In-Law. After my marriage, I have passed my marital life in my matrimonial house only for a period of three months and due to lack of space in my matrimonial house, I along with my husband have compelled to leave my matrimonial house and started to reside at in another house at Subhash Pally, Siliguri. In the Mean time, I became pregnant and gave birth a male child on 04.10.2005 at North Bengal Medical College & Hospital whose name is Rishi Saha. After the birth of our male child, I have found and noticed some radical changes in the attitude and behavior of my husband. He used to return back in the midnight with fully drunken condition and also started to misuse our savings for his ill purpose and as and when I tried to understood him not to behave in such a manner and stopped to consume alcohol regularly, he became more furious and started to assault me with fist and blows in
