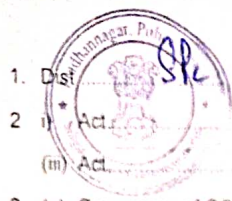

With due respect and humble submission, in producing herewith two accused namely (1) Biki Kumar (23) S/O Sri Rajendar Sha & (2) Shyam Kumar @ Bijay (19) S/O Sri Satuhan Mahato both of Ruhalaganj, Kedrabad, P.S-Lalit Narayan Mithila University, Dist-Darvanga, Bihar under arrest along with following articles under proper seizure ;

1.45 (forty five) Pouch packets of Officer's Choice , Deluxe Whisky ,each packets contains 180 ml ,each MRP Rs .130/-

2.05 (Five) Bottles of IMPERIAL BLUE, Classic Grain Whisky ,each bottles contains 750 ml ,each MRP Rs.590/-

3. 05 (Five) Bottles of Mc Dowell's No1 Superior Whisky ORIGINAL ,each bottles contains 750 ml ,each MRP Rs.590/-

4. 05 (Five) Bottles of ROYAL STAG ,Blender Whisky ,each bottles contains 750 ml ,each MRP Rs.710/-

5.04 (Four) Plastic Bottles of Em Boss Fine Whisky ,each bottles contains 750 ml ,each MRP Rs.195/-

6. 01(One) Blue Colour Trolley Bag

I ASI. Tarun Kanti Ghosh of Pradhan Nagar P.S, SPC would like to lodge a written complainant against the above noted accused person to the effect that today on 26.05.22 at 18.15 hrs myself along with force CV/128 Ajay Sahani ,CV/646 Baban Das,CV/242 Rakesh Mangar left from P.S for Spl mobile van duty vide PDN P.S GDE NO 1682 dt 26.05.22. During mobile duty at 18.25 hrs, I received a source information that two persons standing with one trolley bag at Siliguri Junction area under Pradhannagar PS with suspect articles inside the trolley bag. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and contact with the source and the source identified them. We apprehend them and on interrogation they disclosed their identity which noted above and I also called two local witnesses namely, 1) Sri Naresh Kamti(35) S/O Promod Kamti of Coolipara, P.S-Pradhannagar, Dist.darjeeling & 2) Sri Pram Kr Sha(20) S/O Lt Sriram Sha of Do .In presence of witnesses I searched the trolley bag, during search recovered the above noted articles. On demand they failed to produce any document in favor of recovered liquor, farther interrogation they admitted that they carrying the liquor illegally for selling the same in Bihar state for their illegal gain. Accordingly, I seized & label the above noted articles in between 19.15 hrs to 20.15 hrs and after that I arrested them and brought to Pradhan Nagar P.S.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely (1) Biki Kumar (23) S/O Sri Rajendar Sha & (2) Shyam Kumar @ Bijay (19) S/O Sri Satuhan Mahato both of Ruhalaganj, Kedrabad, P.S-Lalit Narayan Mithila University, Dist-Darvanga and arrange for its investigation.
