1. That today as on dated 13/05/2022 at nearly 11 A.M. at my foresaid address one Sri Manish Agrahari Son of Late Ramasree Shau of Dasrathpally, (Behind Payel Cinema Hall), ward no. 44 SMC, P.O. Sevoke Road, P.S. Bhaktinagar, District Jalpaiguri-734001, came in my house for settlement of a case running against his wife under N.I Act, 1988.
2. That during the discussion he could not control himself and he burst into anger and started to abuse me in filthy languages and caught hold my neck and having hold of my silver chain pushed me back and my broken silver chain was in his hand and he fled away with that Silver chain.
