Respected Sir,

With due respect, I, Krishna Roy, Biren Roy, resident of VPO- Ashokbari, Police Station- Mathabhanga, District- Coochbehar, (WB), want to inform you that as follows:-

1. That, on 26.02.2019 I had entered into an agreement with Smt. Bapi Barman, W/o A Naga Pandi (Reg No. 021462773 CT(GD) 118 Bn BSF, Tagarvila, Kolkata, (WB)) D/o Nanibhusan Barman, resident of Thinikata, near Medical College, Post Office- Sushrata Nagar, Police Station- Matigara, District- Darjeeling, for purchase of a land measuring 2 Katha or 3.30 Decimals situated at Mouza- Bharatsing, J.L. No. 102, in R.S. Plot No. 102/202 corresponding to L.R. Plot No. 172 recorded in R.S. Khatian No. 316 corresponding to L.R. Plot No 1039, under Pargana Patharghata, P.S Bagdogra, Darjeeling , for a sum or Rs. 6,00,000/- (Rupees Six Lacs) only.
2. That before I entered into this agreement one Land broker Sri Sujit Choudhary S/o M.M Chowdhury resident of Kalamjote, P.O Kadamtala, P.S- Matigara, Dist- Darjeeling (WB) who introduced me with Smt. Bapi Barman, and his malicious intention I had entered into an agreement and as per agreement I had paid an amount of Rs. 3,00,000/- (Rupees Three Lacs) only to Smt. Bapi Barman vide cheque No. 502072 dated 26.02.2019 of State Bank of India (Ranidanga Branch). Further said two persons introduce me with Mr. A Naga Pandi who is a BSF personal. Said A Naga Pandi assured me. "You are BSF, I am BSF both are of same Department. (However of different unit) and the land is of my wife therefore you need not required worry".
3. That, as per agreement after 03 month she will give the sale registration in favour of me but after lapse of one month Smt. Bapi Barman had approached to me for additional payment.
4. That, on 04.04.2019 with a criminal conspiracy with the said Sujit Choudhary and with a malicious intention she asked mi if I give hae further Rs. 1,50,000/- (Rupees One Lac Fifty Thousand) only she will the sale deed.
5. That, thereafter again I paid a sum of Rs. 1,50,000 (Rupees One Lac Fifty Thousand) only. Therefore I have already paid 4,50,000/- (Rupees Four lacs Fifty Thousand) only.
6. Thereafter waiting for her, but she avoid me, one day when I got her by phone I asked her about my money of Rs. 4,50,000/- (Rupees Four lacs Fifty Thousand) only but she threatened me with filthy languages and said me that she never return me my money.
7. That, after this incident I tried to contact with the said Sri Sujit Choudhary S/o M M Chowdhury resident of Kalamjote, P.O Kadamtala, P.S- Matigara, Dist- Darjeeling (WB) and on 03.07.2021 with presence of Sujit Choudhary and Smt. Bapi Barman assured me within three months she will return back me the entire amount.
8. After that, few months ago I came to know that Smt. Bapi Barman has already sale out the above mentioned land to one Haripada Ghosh, S/o Manindra Ghosh of Ranidanga, P.S. Bagdogra, Dist Darjeeling by executed a sale Deed before the ADSR II Siliguri at Bagdogra.

They have unduely influenced me and thereafter, they have treated me with fraud and  
surance. They in collusions with each other cheated me.

Therefore, I request to you to look into the matter and do the needful as per law  
and obliged me.
