Sir,

In producing herewith one arrested person namely 1) Bijoy Mandal (28) S/O- Hari Mandal of Santi Nagar Bowbazar near Kali Mandir W/No-36, Bhaktinagar, Dist- Jalpaiguri arrested along following articles along with proper seizure list.

- I) 20(Twenty) PET bottles of Himalayan Gold country sprit 60 UP, containing 600 ml each bottle. (containing in a hand bag)

I ASI Rabin Lama of Siliguri PS, (SPC) would like to lodge this written complainant against the above noted accused person to the effect that on 27.05.2022 at 18:05 hrs myself along with ASI Siben Sarkar and force CV/283 Prasenji Dey CV/ 622 Rama Barman left PS for Special mobile van duty vide Siliguri PS GDE No. 1622/22 Dated- 27.05.2022. During mobile duty at about 19:35 Hrs I received information that one person namely Bijoy Mandal selling huge quantity of illegal liquor selling at Dabgram back side of Polytechnic College under Siliguri PS area. Accordingly, I shared the information to you and as per your kind instruction myself along with force rushed to the spot and held raid at Dabgram back side of Polytechnic College and detained the above noted person along with 20(Twenty) PET bottles of Himalayan Gold country sprit 60 UP, containing 600 ml each bottle containing in a hand bag which was found from his possession. On demand he failed to produce any valid document in favor of the recovered articles. On interrogation he admitted that he has been selling the same illegally since long without any valid document for his illegal gain. Accordingly, I seized the above noted articles under proper seizure list and labeled in between 20:05 hrs to 20:25 hrs and arrested him with proper memo of arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely 1) Bijoy Mandal (28) S/O- Hari Mandal of Santi Nagar Bowbazar, near Kali Mandir W/No-36 Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
