

PETITION U/S 156 (3) Cr.P.C.

Petitioner begs to state as follows:

- 1. That the complainant is an employee of AXIS Bank Siliguri Branch, home Loan Division situated at Sevoke Road Siliguri.
- 2. That in the month of October 2021 the O.P No.1 came for a home loan and your complainant asked for relevant papers which was partly given by the O.P no.1 after a period of four months i.e. February 2022 i.e. KYC, Income Tax details and Papers on the said loan being turned down by the bank authority, and thereafter the aforesaid documents i.e. papers were returned to the O.P No.1 in the month of April 2022.
- 3. That as the O.P No.1 is a Bank Customer and your complainant had been called with malafide intention to the house of the O.P no.1 to entrap him for wrongful gain and the complainant went to the said customer's house on 20.05.2022 at 10:15am. It is pertinent to mention that the complainant went to the house of the O.P No.1 on his brother's motor bike being no. WB74BE2460.

And thereafter O.P No.1 and others of the opposite side started to harass and threatened your petitioner for not clearing the said loan. After physical assault by the O.Ps, who confined your petitioner to an adjacent room brutally assaulted your compliannat and claim that the O.P No.1 had given a sum of Rs. 43 lakhs to the Compliannat for purchase of a land. On protest the O.Ps forcefully locked your Compliannat in an adjacent room and took away three bank debit cards, EMI Card, the said Motor Bike being no WB74BE2460 Keys, Original Aadhar Card, Three Blank Cheques of Axis Bank belonging to the Petitioner and your

petitioner was forced to sign those three blank Cheques. Besides the above the O.Ps forced your petitioner to sign a blank Stamp Paper of Rs. 10/- at gun point and confined your petitioner to a room and thereafter at night your petitioner was taken by a car to the house of the petitioner, where the Petitioner's Parents were also threatened at gun point and forced to sign on the Stamp Paper and while leaving the O.Ps threatened that if the petitioner did not pay the amount demanded i.e. Rs. 43 Lakhs they would not hesitate to kill your petitioner and his family members. They also warned that they have connection with the administration and have threatened to return by 30th May,2022.

4. That over this the complainant tried to lodged a written complaint to the I.C Bhaktinagar P.S on 21/05/2022 disclosing the cognizable offence but to no avail and the Police did not take any steps and thereafter complainant made a complaint to the Commissionerate of Police Siliguri on 24.05.2022, but this to was without effect, as such the complainant file this petition before this Ld. Court u/s 156(3) of Cr.P.C for proper



t is therefore prayed that your Honour would graciously be pleased to treat the complaint as FIR and pass an order by directing the I.C Bhaktinagar P.S, Jalpaiguri to investigate into the matter for the ends of Justice.

And for this act of kindness your petitioner as in duty bound shall ever pray.
