

In producing herewith four (04) arrested accused persons namely (i) Toton Manda yrs s/o Late Sudhir Mandal of Dakshin Santi Nagar near Shib Mandir, Madani Bazar, Boys school PS Bhaktinagar Dist- Jalpaiguri (ii) Subash Barman(40yrs) S/o- Anil Barma Dakshin Bharat Nagar, Debasish Colony, nich para W/no- 24, Ps- Siliguri, Dist- Darje (iii) Rakesh Das(23yrs) S/o- Dulu Das of Bypass, Panganipara near Kankata more, Bhaktinagar, Dist- Jalpaiguri and (iv) Md. Iltaf(19yrs) S/o- Md. Alamgir of Koila De W/no- 07, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following se articles viz:

- 1. One (01) iron made sword measuring 34 inch (approx) including butt from possession of) Toton Mandal which was kept concealed on his back side,
- 2. One (01) iron made sword measuring 29 inch (approx) including wooden butt from possession of Subash Barman which was kept on his right hand,
- 3. One (01) iron made crowbar measuring 20 inch (approx) including wooden ha from the possession of Rakesh Das which was kept concealed on his back side,
- 4. One (01) iron made 'Knife' measuring 11 inch (approx) from the possession of Md. which was kept concealed on his back side,
- 5. One (01) iron made Crowbars measuring 25 inch (approx) and one iron made measuring 36 inch (approx) in length found from the place of occurrence.

I, ASI Siben Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge complaint against the above noted accused persons namely i) Toton Mandal, (ii) Sut Barman, (iii) Rakesh Das, (iv) Md. Iltaf and others namely to the effect that today 01.06.2022 at 00.15 hrs received a sources information that 12/13 persons have assemi at Deshbandhupara behind Indoor Stadium Siliguri PS with a view to commit docoit Deshbandhupara area. The fact was diarized in GD vide Siliguri PS GDE No- 02 da 01.06.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per direction, I along with ASI- Rabin Lama, C/260 Sukundu Roy, C/1048 Gopal Roy, CV/ Prasenjit Dey, CV/622 Ramanath Barman left for the place to work out the information about 00.35 hrs after reaching near Deshbandhupara, I met my source and being pointed the source we started walking towards back of Indoor Stadium. At 00.35 hrs reaching t side of Indoor Stadium started cordoning off the suspected persons as shown by the sou with a strong reason to believe that they were preparing to commit some cognizable offe and was about to move from the spot seeing police personnel approaching towards th They tried to flee away but on hot chase we managed to apprehend above noted four accused persons along with seized articles as mentioned above. However the other pers managed to flee away from the spot taking the advantage of darkness. On interrogation accused persons admitted that they had assembled there to commit dacoity in a house Deshbandhupara area.

I thereafter, seized the above noted weapons under proper seizure list duly signed to the witnesses and acknowledged by the accused persons. The whole seizure was made to between 00.50 hrs to 01.25 hrs. Thereafter, I arrested the above noted accused persons up 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and als supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siligu Police Station for further investigation. During the course of interrogation it could be reveale from the arrested accused persons that they were gathered there to commit dacoity in house at Deshbandhupar area. It is also revealed from them that Baiya, Irshad, Bist Chengu and some others have assembled there with them and planned for committing th dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Toton Mandal 30 yrs s/o Late Sudhir Mandal of Dakshi Santi Nagar near Shib Mandir, Madani Bazar, near Boys school PS Bhaktinagar Dis Jalpaiguri, (ii) Subash Barman(40yrs) S/o- Anil Barman of Dakshin Bharat Nagar, Debasis Colony, nich para W/no- 24, Ps- Siliguri, Dist- Darjeeling (iii) Rakesh Das(23yrs) S/o- Dul Das of Bypass, Panganipara near Kankata more, PS- Bhaktinagar, Dist- Jalpaiguri and (iv Md. Iltaf(19yrs) S/o- Md. Alamgir of Koila Depot, W/no- 07, PS- Siliguri, Dist- Darjeeling an others and arrange for its investigation.
