Sir,

I, ASI Jakirul Islam of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one arrested accused person namely Harish Munda (20) s/o Sohan Munda of Gangaram Tea Estate, Boro Line PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

- 1. Seven (7) sealed Bottles of Kingfisher strong Premium Bear, each bottle 650 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
- 2. Eight (8) sealed Bottles of Tuborg Strong Premium Bear, each bottle 650 ml each Marked as exhibit -B in which 01 bottle taken as sample for examination exhibit-B1.
- 3. One Nylon Bag which used to carry the Liquor noted in SL.No. 1 & 2.

I am submitting a written complaint against the above noted accused person to the effect that today 05.06.22 at 19-45 hrs received secrete source of information that one person was selling Liquor illegally at Bagdogra Bihar More near Bus stand to its customers without any valid license. Accordingly the duty officer of Bagdogra PS noted the information in GD vide Bagdogra PS GDE No. 268 dt. 05.06.22 and informed to O.C. Bagdogra PS and as per instruction myself along with QRT mobile van officer ASI Pradip Roy and force and CV- 386 Kishor Hawlder CV- 389 Janak Singh, VP- 02 Pradip Roy had been to the spot to verify the veracity of information. On arrival at the spot at 20-15 hrs it was found that one person mention above was selling liquor illegally at Bihar More near Bus stand to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by me, On being asked he disclosed his name and address mentioned above. There after I called two disinterested witnesses namely (1) Debasish Sarkar (30) s/o Dilip Sarkar of Gossainpur Rupsinghjote PS Bagdogra Dist. Darjeeling and (2) Rana Das (28) s/o Ratan Das of Sricolony PS Bagdogra Dist. Darjeeling in the very presence of the witnesses I with the help of others police personnel searched and recovered 1. Seven (7) sealed Bottles of Kingfisher strong Premium Bear, each bottle 650 ml, 2. Eight (8) sealed Bottles of Tuborg Strong Premium Bear, each bottle 650 ml each which was kept in a Nylon bag from the possession of the apprehended person and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. This seizure & arrest was made in between 20-45 hrs and 21-35 hrs (seizure Total 9.7 Lts).

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Harish Munda (20) s/o Sohan Munda of Gangaram Tea Estate, Boro Line PS Bagdogra Dist. Darjeeling and arrange for its investigation.
