After marriage I started conjugal life with my husband in my in laws house. That since after marriage, my Mother-in-law namely Manju Devi and two brother-in-law namely Prakash Mandal and Dhiraj Mandal started abusing me and torturing me without any reasons, not only that they used to assault me physically and mentally and asked me to bring money as dowry although the demand of them had to fulfilled at our marriage by our

Although my husband is still in my favour and he also protest against his family members but they did not care about it. Inspite of happened the above incident for leading happy conjugal life I used to tolerate and when I used to alone in my room at that time my two brother-in-law trying to molest and sexually assault me by entering my room without my permission and inspite of knowing the matter my mother-in-law also support them and when my husband protest against the above incident my mother-in-law threat him to evict from his house permanently.

On 02/06/2022 at about 5:30 p.m. my Mother-in-law, two brother-in-law started to torture me by demanding dowry again and my two brother-in-law tear my clothes trying to disrobe me at that time my husband was not present at house and also hit me badly for that blood comes from my nose and my son also hurted. At that time in any way I managed to handle myself because I am also a heart patient and after my husband came to house he protest against his mother and two brother, then they also threat me and my husband to repulse from the house. They did the same incident towards us in many times and they also trying to thrown out us from our house by cutted the electricity connection, water connection and not to use the bathroom also. We have a 9 years old son and for the above behaviour of my in-laws it is very difficult for us to staying in our house safely.

So, it is humbly request you to take strong action against my mother-in-law, two brother-in-law because me, my husband and our son are feeling scared and unsafe from them because they can do anything with us in any time.
