## Sub: F.I.R.

Sir,

I, Sri Bhagwati Prasad Luhariwala, s/o Late Laxmi Chand Luhariwala, r/o Reshep . Bazaar, P.O. – Mungpoo, Dist – Darjeeling, would like to inform you that I am an old, aged and ailing person suffering from acute heart disorders and is continuously undergoing treatment. I, for my settlement and business purposes of my sons purchased a piece and parcel of land measuring 24 kathas or 0.40 acres, recorded in Khatian No. – 4/5, Plot Nos. 314 and 316 under Mouza – Kalkut, P.S. – Pradhan Nagar, Dist – Darjeeling, by virtue of a registered Deed of Sale being No. – 1496 for the year 1987 executed by 1) Smt. Bharati Ghosh, w/o Sri Sunil Kumar Ghosh and 2) Sri Sunil Kumar Ghosh, s/o Late Radhika Mohan Ghosh, both residents of Telipara, Jalpaiguri.

After purchasing the same, I constructed a boundary wall around the said land and used to possess the same since purchase and it remained vacant. As I was residing at a different place I used to visit the said land off and on. But, due to my illness during the year 2015, I went to Vellore for treatment and was there for a considerable time. However, on return from there when I went to see the said land, I could see that 1) Prabhu Nath Prasad, s/o Late Harihar Prasad, 2) Kush Kumar Prasad, s/o Prabhu Nath Prasad, both residents of Ganesh Ghosh Colony, Naya Busty, Siliguri, P.O. & P.S. – Pradhan Nagar, Dist – Darjeeling, 3) Naren Prasad, s/o Ramji Prasad, r/o Ambika Nagar, Angshik Fulbari, P.O. & P.S. – New Jalpaiguri, Dist – Jalpaiguri, 4) Raj Kumar Gupta, s/o Late Laxmi Prasad Gupta, r/o Anandamayee Colony, Ward No. – 46, P.O. & P.S. – Pradhan Nagar, Dist – Darjeeling and 5) Smt. Anjali Chowhan, w/o Jogesh Chowhan, r/o Ambika Nagar, Angshik Fulbari, P.O. & P.S. – New Jalpaiguri, Dist – Jalpaiguri trespassed into my land by breaking the part of the boundary wall on the front side and they also made some shops / showrooms of different materials and kinds over different portion of the said land therein.

When I asked them about their such illegal acts they claimed that they purchased the said land during the years 2014 and 2015 from different persons although they have no authority to do the same nor I sold the same to them. The said land is within the Siliguri Municipal Corporation and my name has also been recorded in the Holding No. -VL/100/C/15 of Ward No. - 46 and I used to pay Municipal Taxes for that. Those persons although having no right, title and interest are desperate in nature and associated with criminals, land brokers of the locality. Considering my helplessness, they threatened me with dire consequences if I dare to go there.

Therefore, apprehending danger and facing hardship to protect my aforesaid landed property and also risk and danger of my life, I had been running from pillar to post even to the law enforcement authorities but without any solution as yet. I, being an old man of 69 years with my ailments feeling helpless would like to request you to take appropriate action so as to evict those persons from their illegal occupation from my said property at the earliest and to take action against them for their such illegal and offending acts.
