I, Smt. Rinku Roy, W/o. Late Hiranmoy Roy @ Bapi, R/o:- 2no. Jyotinagar Colony, Ward No:- 4, P.O & P.S:-Siliguri, Dist:- Darjeeling beg to inform you that on 05/06/2022 at about 10.30 A.M. my neighbours namely 1. Sri Pankaj Saha, S/o. Sri Pradip Saha, 2. Sri Pradip Saha, S/o. Not Known, R/o. above noted address without any reasons they came in front of my house and after coming in front of my house they without any reasons started to used slang languages in respect of me and after listening the same when I came in front of them and told them do not used any slang languages in respect of me and my family and I tried to protested the same at that time they became ferocious and started to assaulted me with fist and blows and during that period after listening my hue and cry my son namely Sri Tanmoy Roy @ Nathu came to spot and tried to rescused me at that time they became more ferocious and during that time they called their another family member namely 3. Smt. Suchanda Saha, W/o. Sri Sri Pradip Saha and after coming to the spot they all of them started to assaulted my son by using Lathi, Bamboo Etc and for that reasons my son sustained multiple injuries on his whole body and specially lower portion of body and for the assaulted by them my son became senseless and and after listening our hue and cry local people came to the spot and rescued me and my son from their hands and it is also right palce to mention here that at the time of the said incident the above noted person namely 1. Sri Pankaj Saha, S/o. Sri Pradip Saha, 2. Sri Pradip Saha intentionally disrobe me in presence of the local people by way of santching my saree and also by way of pulling my hair and when they left the above noted place they also threatened me with dire consequences and also told me that they will come again and kill us if I or my family members lodged any complaint against them and for that reasons I and my family members till now spend my days with-in very bad conditionbut today with the help of the local people I lodged this written complaint before you against the above noted persons.

Therefore, I request you be pleased to accept my aforesaid written complaint and take necessary legal actions against the above noted persons as early as possible.
