This is to inform you that I, Smt. Bhawna Pradhan W/o Sri Biplab Mothey at present residing at Sukna Part within P.S. Sukna, Dist Darjeeling like to inform you the following facts for your necessary action, Please.

That today at about 10 a.m. I received a telephonic information in my mobile phone from my mother Smt. Jharna Pradhan W/o Sri Ram Bahadur Pradhan from Mungpoo that my younger brother Sri Pratisodh Pradhan S/o Sri Ram Bahadur Pradhan while coming to Siliguri on his Scooty bearing No. WB74BH6120 met with an road accident at NH near Bengal Safari zoo. My mother also told me that she received phone call from one Sri Safal, driver of a pickup Van, a resident of Mungpoo who stated that a LMV Mahendra SUV bearing registration No. SK 04 PA0512 coming from opposite direction (from Siliguri) hit the scooty of my said brother causing severe injury to my brother and he along with the driver of the offending vehicle and other immediately took him to Life Line Nursing Home at 2.5 mile where he is admitted in critical stage.

That on receipt of this call I reached at the Life Line Nursing Home within one hour and I my parents had also arrived at the Nursing Home. We found that my brother lying in unconscious condition having multiple injury on his person. The police personnel from your P.S. were also present there as they might be informed by the Nursing Home authority due to police case.

It is evident that the driver of the offending vehicle bearing No. SK04 PA0512 was driving in rash and negligent manner and due to which this accident happene.

I, therefore, request you to kindly diarised this fact and treat my complaint as an FIR by starting criminal case against the offending driver as per law.
