That after the said Order and Judgment was delivered and decree was drawn up, I made arrangements to construct boundary wall in my land but as soon as I put certain construction materials on the land, the said Kadu Nath Roy, other legal heirs of Late Gulal Singh Roy and their men and agents came to the aforesaid land and caused hindrance in undertaking such construction work. Thereafter I lodged a FIR at your police station on 22.01.2021 and 17.09.2021 which was duly registered as FIR being NJP PS case No. 1053 of 2021 dated 17.09.2021 u/s 420/465/468/471/501/441/120B. That even after such FIRs, no action was taken against the said Kadu Singh Roy, Legal heirs of Late Gulal Singh Roy and their men and agents.

Yesterday, i.e., on 11.06.2022 when I went to my land with the intention to make construction of boundary wall, I had taken my workers to clean and level the land in order to initiate construction of the boundary wall. The men and agents of the said Kadu Nath Roy came to my land and again caused hindrance and obstruction in such construction. Thereafter, the said Kadu Nath Roy arrived in my land with more men carrying lathis, sticks and other weapons and threatened me and my men and laborers from undertaking any work in my land and further threatened me of dire consequences if I made any attempts to make construction.

I have also come across another Deed of Sale executed by Kadu Nath Roy in favour of Shri Nihar Sarkar vide a registered deed of Sale being Document No. 2536 of 2021 registered in the Office of the District Sub Registrar, Jalpaiguri whereby 43 decimals of land has been fraudulently transferred from my land measuring 1.18 acres. The said Kadu Nath Roy and Nihar Sarkar have conspired amongst each other and executed and registered the said Deed by fraud and forgery thus cheating me for their illegal gains.

I am aged about 84 years, a heart patient with failing health and inspite of decree of the Court I am being prevented from constructing boundary wall on my land by the aforesaid persons who have indulged through conspiracy and committing fraud, forgery of land records and preparing forged title deeds and are also guilty of causing intimidation, threat, physical assault to an old man like me and also cheating me for their illegal gains. Hence I request you to take immediate and appropriate steps against the aforesaid persons and ensure that I am not disturbed or obstructed by the said persons during construction of boundary wall on my land.
