Sir,

With due respect I Sri Manoranjan Barman, Son of Sri Mahendra Nath Barman, residing at Dakshin Shanti Nagar, under Dabgram II Gram Panchayet, Post Office Dabgram -2, Police Station Bhakti Nagar, District Jalpaiguri, Pin 734004, in the State of West Bengal proprietor of Tanisha Egg Center situated a E. M. bye pass, P.O. Ghooghmal, P.S. Bhakti Nagar, District Jalpaiguri, would like to inform you that I am the owner of an Egg Godown situated at Hatiadanga, Near Jaleshwari Bazar, P.O. Sahudandihut, P.S. Bhakti Nagar, District Jalpaiguri.

That on yesterday i.e 12-06-2022 near about at 11.30 p.m. suddenly One Sri Jayanta Roy, Son of Sri Jaydeb Roy along with 4 to 5 persons came to my godown and forcefully entered into the godown and demanded a huge amount of money from my caretaker cum truck driver Manoranjan Adhikary and Tanmay Maji, as usually when he denied to pay any money to them the said Sri Jayanta Roy, Son of Sri Jaydeb Roy along with his associates started using slang languages and has broken the front glasses of my 10 wheeler trucks bearing Numbers WB73E3451 and AP05TD7179 which were parked at the premises of my Egg Godown when my caretaker tried to resist them, they attacked on him with weapons.

That in the meantime my caretaker cum truck driver call me over phone and after getting the information from the caretaker cum truck driver I along with my younger brother Sri Biswaranjan Barman came to my Godown and found that my 2 (Two) 10 wheeler trucks were damaged as my driver described over Phone and my driver & Other persons were also injured.

That as a Good citizen and Law abiding person I went to the Ashighar Out Post near about 12 a.m. to inform the incident to the concern authority and after hearing the incident the authority sent some officials to the spot and found the damaged trucks and the injured persons there. As per my verbal complaint the officials searched for the abovesaid Sri Jayanta Roy but as he was not in his house, they did not found him. After that I came to Ashighar outpost along with police persons and my brother Sri Biswaranjan Roy stayed at my godown with the caretaker. Near about 1.00 to 1.10 a.m the said Jayanta Roy, his father Sri Jaydeb Roy along with 10 to 12 persons again came to my godown with deadly weapons like swords and rods and threatened my younger brother with dire consequences saying that it was our wrong decision to inform the police personnel about the matter and started to throw stones towards my trucks and staff rooms. When my younger

brother said Sri Biswaranjan Barman tried to resist them the said Jayanta Roy and his associates hurt him with rod and sword. They snatched a gold chain from his neck and took away an amount of ₹10,000/- (Rupees Ten Thousand) from him, and openly declared that police will do nothing against them, they have long channel or source and again my brother call me at that time I was present at Ashighar Outpost and after getting information immediately inform to the police persons about the second attacked and again police person came to the spot and they have quit the place in the meantime.

As a consequence my younger brother has been injured with heavy bleeding and thereafter he was taken to the North Bengal Medical College for his treatment and stitches has been done in his right hand. (The copy of his treatments is enclosed with this copy)

Thereafter near about 3.30 a.m. the said Jayanta Roy, his father Sri Jaydeb Roy along with 10 to 12 persons again third time came to my godown and again damaged my vehicles, caretaker cum truck driver rest room by stones they also threatened that if we further inform the matter to the police or take any step against them, they will kill us and fled away.

Under the aforesaid circumstances, finding no other alternate I am lodging this F.I.R against the aforesaid Jayanta Roy, his father Jaydeb Roy and their associates before you.

In view of the above I would like to request you to kindly take necessary steps immediately against the above offenders and do the needful as we are living our life in danger.
