I ,Sri Suman Sarkar , S/O- Late Sunil Kumar sarkar Assistant Engineer & Station Manager ,WBSEDCL, Siliguri Town CCC under P.S. Siliguri empowered by the Electricity Act 2003 (Amendment Act 2007) do hereby lodged this complaint against Sibasish Mitra(present User),s/o Late Bijay Kumar Mitra premises at Bijoy Enterprise ,Meghdoot Cinema Hall Complex ,H.C. Road ,Siliguri for committing unauthorized shifting of electric meter U/S 136 1(a) of the Electricity Act read with Amendment Act 2007 as stated here under.

On 14.06.2022 at about 11:00 AM , Sri Suman sarkar along Muchha Mondal , Sri Sourav Bhattacharya ,Sr. O.E. ,Rabi Chettri ,Hg. Gr. Sr. LM Siliguri Town CCC Conducted one surprise checking premises at Bijoy Enterprise ,Meghdoot Cinema Hall Complex ,H.C. Road ,Siliguri .

During inspection offence U/S 136 1(a) of the Electricity Act was detected. The accused person Sibasish Mitra,S/o Lt. Bijay Kumar Mitra was using electric power for commercial purpose from LT service Meter No L012118 which is issued in the name of his father premises at Meghdoot Cinema Hall Complex, H.C. Road ,Siliguri . Write to note here that the said meter(i.e. L012118) was issued in the name of Bijay Kr Mitra, since dead and his son is using the same. But during inspection it has been found that the meter (i.e. L012118) was already shifted from that particular place and we could not trace out the meter at his premises. For more information, a construction work is going on that premise, engaged meter no BF016286 in the name of pradipt kumar Saha. During the connection process of that construction power ,Sri Sibasish Mitra came to the office and informed us that the meter bearing No L012118 was not nexus with Him. At that time, he also Said that the meter bearing no L012118 was existed out of the construction zone. But unfortunately meter was shifted unauthorized way from the place.

As unauthorized shifting of Electric meter was detected during inspection bearing meter serial number L012118 and the accused person noted above committed offence U/S 136 1(a) Electricity Act 2003 and amendment Act 2007. So you are hereby requested to take necessary action.  
This letter will be treated as F.I.R. u/s 136 1 ( a) of Electricity Act 2003.
