I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Gosto Behari Das (Present user), Ph no- 9832747418, S/o- Lt. Nripendra Behari Das, Muzaffar Ahmed Sarani, Near Pakurtala More, Ashrampara, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 14.06.2022 at about 12.55 p.m. acting on a source information I, along with 1) Sri Malay Kr. Goswami, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the under construction building at Muzaffar Ahmed Sarani, Near Pakurtala More, Ashrampara, Siliguri, Dist- Darjeeling and inspected service installation, metering installation of Consumer ID 412025489 in the name of Sushila Devi Agarwal. During inspection it was found that electricity was being used unauthorised & illegally by Gosto Behari Das (Present user) by reconnecting the disconnected service line of the metering installation that was disconnected previously on 20.12.2017 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Landies & Gyer Ltd, serial no.- L3313225 & 5(five) meter approx. PVC wire installed against Con Id. 412025489 seized by preparing a formal seizure list duly signed by representative of Gosto Behari Das (Present user) and witnesses. The copy of the seizure list handed over to representative of Gosto Behari Das (Present user) and his signature obtained as token of receipt.

As Gosto Behari Das (Present user) have committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity unauthorised & illegally by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR.
