Goswami, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the under construction building at Muzaffar Ahmed Sarani, Near Pakurtala More, Ashrampara, Siliguri, Dist- Darjeeling and inspected service installation, metering installation of Consumer ID 412025489 in the name of Sushila Devi Agarwal.
