Darjeeling would like to inform you that my mother namely Reba Dey is the absolute owner in possession of the land measuring 35 Kathas recorded in Khatian No. 36/2 (old) and 1621 (new), Plot No. 125 (old) and new plot no. 211, Mouza - Khawakhali, P.S. Matigara, Sub-Division - Siliguri, Sub-Registry Office - Siliguri (now Bagdogra), District - Darjeeling, (W.B.) by virtue of two separate deeds of sale being no. 1802 for the year 1991 purchased from one Sri Birendra Kumar Saha, Son of Late Bankim Chandra Saha, land measuring 20 Katha or .33 acre and deed of sale being no. 1803 for the year 1991 from one Sri Atul Chandra Saha, Son of Late Nani Gopal Saha and since the date of purchase she is possessing and enjoying the said land. 
