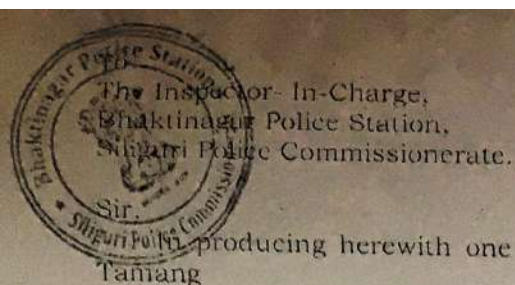

producing herewith one (01) arrested accused person namely Sushma Tamang (44) W/O- Ratan Tamang
Bikash nagar, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri along with the following articles under proper seizure as per seizure list;

- a) Winspasma Forte. Capsules having Batch No. WP522009 Mfg. Date-02/2022 Exp. Date-01/2024 total amount 640 Capsules each capsule weight 0.5 grm . and marked as "Exhibit- A".
- b) 04 (Four) bottles of "ONEREEX" Cough Syrup (each bottle containing 100 ml) having Batch No. 191121-SD28, Mfg. Date: 11/2021. Exp. Date: 10/2023. and marked as "Exhibit- B".
- c) 06 (Six) bottles of "Ralirex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHV0644, Mfg. Date: 05/2022. Exp. Date: 04/2024. and marked as "Exhibit- C".
- d) One Violet colour hand bag.

Seized from the Exclusive and conscious possession of above noted Sushma Tamang.

I, SI Rantu Halder, S/O- Manoranjan Halder of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Sushma Tamang Bikash nagar, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that on 17.06.2022 at about 14.15 hrs I received a specific source input that one person, possessing huge quantity of 'Codeine Phosphate' based drugs, in his house Bikash nagar, Salugara, under PS Bhaktinagar to sell the same to his designed customers. The matter was diariized in Bhaktinagar PS GDE No. 846 Dt. 17.06.2022 and subsequently, I informed the matter to the Inspector-in-Charge, Bhaktinagar Police Station in written and being directed. myself along with ASI Dipak Barman, Const- 986 Rajib Sarkar and LC/1584 Rupni Oraon CV/619 Dharmendra Roy CV/935 Biplab Barman all of Bhaktinagar PS, SPC along with necessary investigation kit left for Bikash nagar, Salugara, under PS Bhaktinagar by Govt. vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE No. 847 Dt.17.06.2022 and M.C.C No-304/2022 Date- 17.06.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On way to Bikash nagar, Salugara, under PS Bhaktinagar under Bhaktinagar PS I contacted two persons namely (1) Priya Rai (27) D/O- Lt Bhim Sen Rai of Bhanunagar, W. No 43, P.S- Bhaktinagar, Dist- Jalpaiguri and (2) Rajiv Rava (21) S/O- Babu Rava of Bhupendra nagar, P.O- Salugara P.S- Bhaktinagar, Dist- Jalpaiguri and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at Bikash nagar, Salugara, under PS Bhaktinagar at 14.45 hrs and subsequently, being pointed by my source detained 01 (one) woman residing at his house. She had carried one violet colour hand bag in her right hand. Thereafter, we disclosed our identity and the information in hand and stated her that she as well as the bag under her possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which she agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but She did not search the police party. Consequently, I informed the matter to I/C Bhaktinagar PS regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Bikash nagar, Salugara under Bhaktinagar PS to remain present and to supervise the search and seizure.

Accordingly at 15.15 hrs Shri Amaresh Singh I/C Bhaktinagar PS acting as Gazetted officer of SPC arrived at the spot at Bikash nagar, Salugara under Bhaktinagar PS as Gazetted officer, SPC and in presence of two independent witnesses LC/1584 Rupni Oraon searched the detained person following all formalities, keeping her decency and recovered the above noted article from the exclusive and conscious possession of the accused person namely Sushma Tamang (44) W/O- Ratan Tamang Bikash nagar, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri

On being searched of the said detained person found Winspasmo Forte Capsules having Batch No. WP522009 Mfg. Date-02/2022 Exp. Date- 01/2024 total amount 640 Capsules total weight $0.5 \times 640 = 320$ gm. [04 (Four) bottles of "ONEREEX" Cough Syrup (each bottle containing 100 ml) having Batch No. 191121-SD28, Mfg. Date: 11/2021. Exp. Date: 10/2023. Containing $4 \times 100 \text{ ml} = 400 \text{ ml}$ i.e., equivalent to 0.4 Kgs. 06 (Six) bottles of "Ralirex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHV0644, Mfg. Date: 05/2022. Exp. Date: 04/2024. Containing $6 \times 100 \text{ ml} = 600 \text{ ml}$ i.e., equivalent to 0.6 Kgs. Total $0.4 + 0.6 = 1$ Kgs.] Which was kept into a violet colour hand bag carried by the detained person namely Sushma Tamang (44) W/O- Ratan Tamang Bikash nagar, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri

Further, on demand in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for acting as Gazetted officer of SPC the detained person namely Sushma Tamang failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered Winspasmo Forte Capsules having Batch No. WP522009 Mfg. Date- 02/2022 Exp. Date- 01/2024 total amount 640 Capsules. [04 (Four) bottles of "ONEREEX" Cough Syrup (each bottle containing 100 ml) having Batch No. 191121-SD28, Mfg. Date: 11/2021. Exp. Date: 10/2023. Containing $4 \times 100 \text{ ml} = 400 \text{ ml}$ i.e., equivalent to 0.4 Kgs. 06 (Six) bottles of "Ralirex" Cough Syrup (each bottle containing 100 ml) having Batch No. TBHV0644, Mfg. Date: 05/2022. Exp. Date: 04/2024. Containing $6 \times 100 \text{ ml} = 600 \text{ ml}$ i.e., equivalent to 0.6 Kgs. Total $0.4 + 0.6 = 1$ Kgs.] from the exclusive and conscious possession of above noted accused person namely Sushma Tamang at the spot at Bikash nagar, Salugara under Bhaktinagar PS under proper seizure list in presence of independent witnesses and Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for acting as Gazetted officer, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for Gazetted officer, SPC and independent witnesses and the accused person namely Sushma Tamang The whole process of seizure was made in between 15.25 hrs to 16.05hrs.

Being further asked, the apprehend persons namely Sushma Tamang admitted in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer of SPC and other independent witnesses that She has procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. She also disclosed that She has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Sushma Tamang is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Sushma Tamang (44) W/O- Ratan Tamang Bikash nagar, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person Sushma Tamang (44) W/O- Ratan Tamang Bikash nagar, Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
