1. Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 15 = 1800/-)

I ASI Rabin Lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Deep Sarkar 20 yrs S/o Late Tulu Sarkar of Tikiapara, near Power House, ward no 28, PS- Siliguri Dist-Darjeeling to the effect that on 17/06/2022 at about 18.45 hrs during my mobile van duty (vide Siliguri PS GDE no-1007 dated 17/06/2022) I received a source information from Sarbahara colony, ward no 28 under Siliguri PS, that one person namely Deep Sarkar is selling huge quantity of liquor illegally at Sarbahara colony, Sabji Market, under flyover in his shop, to his design customers since long for his wrongful gain. After received the information myself along with, ASI Siben Sarkar, CV/ Prosenjit Dey, CV/ Ramanath Barman proceeded to the P.O to work out the veracity of information. After reaching the spot and on being identified by the source our police team held raid in the shop and we managed to apprehended the said person after searched our team recovered Fifteen (15) bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, (Total market value of worth RS/- 120 x 15= Rs/- 1800). On demand he failed to produce any valid licence in support the said liquor, on interrogation he disclosed his name and address as noted above and he confessed his guilt, accordingly I seized the liquor from the possession of Deep Sarkar, as per proper seizure list in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Deep Sarkar 20 yrs S/o Late Tulu Sarkar of Tikiapara, near Power House, ward no 28, PS- Siliguri Dist- Darjeeling under proper section of law.
