1] Total 32 (Thirty Two) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 19.2 liters).

I, PSI-Pradeep Diyali presently posted at New Jalpaiguri Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted persons that today (17.06.2022) at 18.55 hrs. acting on source information, myself along with ASI Sajal Das, HG/794 Ranjit Roy, VP/08 Laxman Roy, VP/13 Jamirul Islam and CV/116 Rohit Kumar Mahato all of New Jalpaiguri PS, Siliguri Police Commissionerate had been to NJP Hotel Line area near NJP parking Rail Way station and found that the aforesaid persons had been selling illegal liquor to the common customers at their shop at NJP Hotel Line area under P.S- NJP. Then I cordoned the place with my accompanied force and detained them who on being asked disclosed their identity as noted above and stated that they used to sell illegal liquor at this place for their wrongful gain since very long. On being search of them in presence of available witnesses the above noted seized articles are found inside a bag from their conscious and joint possession. On being asked they failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned persons. While on the time of cordoning off the place, the persons who were having liquor at that place manage to flee from the spot. On further interrogation of the arrested persons it could be learnt that they is involved in selling and possessing the liquor without any valid license for their illegal gain. The seizure has been made in between 19.55 hrs. to 20.45 hrs.
