Respected Sir,

In producing herewith one arrested accused person namely Pravat Biswas(M/38), s/o Lt Paresh Biswas of Chayan Para Bazar, Asigarah, PS-Bhaktinagar, Dist-Jalpaiguri along with seized articles:

- 1. 12 (Twelve) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 600 ml each, MRP Rs. 120/-
- 2. 01(One) Nylon Bag which used for carrying the seized articles SL. No. 1

I, ASI Surajit Mallick of Panitanki TOP under Siliguri PS/SPC herby lodge a written complaint against the above noted accused person to the effect that today i.e. on 28.06.2022 in course of my Evening Mobile van duty I received one secret source information to the effect that one person in side of Bidhan Market near Das Shop under Siliguri Police Station have gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. Accordingly the said information shared to O/C, Panitanki TOP and thereafter as per his kind instruction I along with, Const/153 Santosh Mahato, CV-377 Dinesh Roy as proceeded at in side of Bidhan Market near Das Shop under Siliguri Police Station to work out the information. At 18.45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid in the said market and recovered the above noted articles from the possession of above noted accused person namely Pravat Biswas. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized 1) 12 (Twelve) Bottles Country Spirit styled as 60 UP PET Himalayan Gold of 600 ml each, MRP Rs. 120/- and 2) One Nylon Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labelled the same in presence of witnesses also by the accused person. The seizure was made between 19.15 hrs to 19.55 hrs on 28.06.2022. Then I arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Pravat Biswas(M/38), s/o Lt Paresh Biswas of Chayan Para Bazar, Asigarah, PS-Bhaktinagar, Dist-Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
