In producing here with the one arrested accused person namely Damayanti Dahal (F/35) W/O- Lt Binod Dahal of Kalimpong, Mangal Dhara, PS- Kalimpong, Dist- Kalimpong along with the following seized articles as per proper seizure list:

(I) 10(|Ten) Bottles of Himalayan Gold 60up Country Spirit (each Bottle containing 600ml)

(II) 05 (Five) bottle of kingfisher Strong Beer (each bottle containing 650 ml)

I, ASI NItai Mandal of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 28.06.2022 while performing special raid duty under Bhaktinagar PS area vide BKN PS GDE No. 1483 Dated. 29.06.2022 at about 15.05 Hrs I, received a source information that the above noted accused person have possessed huge quantity of Liquor carrying for the purpose of selling at Salugara Bazar under Bhaktinagar PS. Accordingly I shared the information to I/C Bhaktinagar P.S/SPC as per his direction I, along with C/986 Rajib Sarkar, CVF/935 Biplab Barman CV/614 Sumit Kr Roy and LCV/1060 Goma Bhandari headed towards Salugara Bazar to verify the veracity of the information. We reached at Salugara Bazar as shown and being identified by the source held raid and apprehended one person who disclosed her identity as noted above. Further maintaining her decency and observing all formalities and with the help of LCV/1060 Goma Bhandari searched her and recovered above noted seized liquor from her possession. On demand She failed to produce any valid documents/licence in respect of the recovered liquors. On interrogation the apprehended person admitted her guilt and confessed that She has possessed above noted liquor at Salugara Bazar for the purpose of selling to his designed customers for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made in between 15.45 Hrs to 16.25 Hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the accused her u/s 41 Cr.P.C appraising his ground of arrest.

I, therefore pray before your kind honour that a specific case may kindly be registered against the accused person namely Damayanti Dahal (F/35) W/O- Lt Binod Dahal of Kalimpong, Mangal Dhara, PS- Kalimpong, Dist- Kalimpong under proper section of law and arrange for its investigation.
