1. PSI Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 27.06.2022 at 22.15 hrs I received a secret source information that one person namely Shyam Sundar Kamti (40) S/O Kari Kamti of South Colony, P.S. NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at NJP Station area under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1344 dated 27.06.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy and VP/13 Jamirul Islam all of NJP PS, SPC left for NJP Station area, PS- NJP to work out the information in hand. At about 22.25 hrs we arrived at NJP Station area and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop.
