I, SI Goutam Mallik of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Tahirul Hoque (40 yrs) S/O late Afsar Ali of Dakshin Odlabari Colony, PO- Manabari,, PS-Malbazar, Dist.- Jalpaiguri A/P residing at Rana Busty, PS- Matigara, Dist.- Darjeeling to the effect that on 30.06.2022 at 14.45 hrs received a source information that one person named Tahirul Hoque of Odlabari and A/P residing at Rana Busty, PS- Matigara, Dist.- Darjeeling is selling liquor in his residence at Rana Busty under PS - Matigara, Dist.- Darjeeling without any valid license. Accordingly the fact is diarized in General Diary vide Matigara PS GDE No 1563, Dated 30.06.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to Rana Busty to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of Tahirul Hoque of Odlabari and A/P residing at Rana Busty, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the house of the said accused. On enquiry it could be revealed that he is permanently residing at Odlabari but presently residing at Rana Busty under PS- Matigara, Dist.- Darjeeling and illegally selling illicit liquor at his residence since few months. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Tahirul Hoque (40 yrs) S/O late Afsar Ali of Dakshin Odlabari Colony, PO- Manabari, PS-Malbazar, Dist.- Jalpaiguri A/P residing at Rana Busty, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 30.06.22 in between 15.45 hrs to 16.25 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against accused Tahirul Hoque (40 yrs) S/O late Afsar Ali of Dakshin Odlabari Colony, PO- Manabari, PS- Malbazar, Dist.- Jalpaiguri A/P residing at Rana Busty, PS Matigara, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
