Sir,

In producing herewith one arrested person namely Dulali Sahani (51/F) W/O Jugeswar Sahani of Hakars Cornar, ward No-18, PS- Siliguri, Dist- Darjeeling along with seized articles VIZ:- (i) 06 (six) bottles of Himalaya Tuk Tuk Country spirit each bottles containing 600 ML. & MRP Rs 55/- each bottle, (ii) 05 (five) bottles of Prakash 60 Country spirit each bottles containing 600 ML. & MRP Rs 120/- each bottle, and (iii) 13 (thirteen) Tetra Pack of Officer's Choice Deluxe Whisky containing 180 ML each Pack Total RS. 2620/- Only. (two thousand six hundred twenty)

I ASI Md. Sanjay Hasda of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 30.06.2022 while my performing K-27 morning van duty at 09.40 hrs received an information that one lady person has carrying the huge quantity of illegal liquor which was kept in the plastic bag for her wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO – 743 Dated-30.06.2022. As per information I inform to O/C Khalpara TOP under Siliguri PS and as per his kind direction myself along with force with lady constable 1612 Pushpanjali Yanzone proceeded to the PO to work out the information. At 09.55 hrs. we reached at Mahabirsthan Rail gate under Siliguri PS, Dist- Darjeeling some times after being identified by the source our police party held raid and recovered the above noted articles from her possession of above referred lady person. On demand she could not produced any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in open marked for her wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and with level and took signature of the lady accused person on one bottles each taken as sample .The seizure was made in between 10.00hrs to 10.35hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the lady accused person namely Dulali Sahani (51/F) W/O Jugeswar Sahani of Hakars Cornar, ward No-18, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation .
