During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Ashrampara adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 05 (Five) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each (ii) 05 (Five) Bottles Country Spirit styled as 70 UP PET "HIMALAYAN FATA FATI" of 300 ml each, MRP Rs. 28/-(iii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I) & (II).

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 05 (Five) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each (ii) 05 (Five) Bottles Country Spirit styled as 70 UP PET "HIMALAYAN FATA FATI" of 300 ml each, MRP Rs. 28/-(iii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I) & (II) under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person and arrested him.
