SI Sibdhan Karmakar of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons and others to the effect that on 29.06.22 at 23.55 hrs I received a source information that 9/10 persons were assembled at Milon More ,Mahananda River Side under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. Accordingly I inform to you and diarized the matter vide PDN PS GDE No. 1810 dtd.29.06.22 and as per your kind instruction myself along with C/762 Mojibar Rahaman, Cv/223 Swapan Chhetri, CV/128 Ajay Kr Sahani , CV/242 Rakesh Mangar, CV/646 Baban Ch Das, took departure for the spot . We reached near the spot as confirmed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.55 hrs and we reached at Milon More, Mahananda River Side under Pradhan nagar P.S and found a group of 9/10 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately, one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple directions. Somehow, after a hot chase we could able to apprehend the above noted 05(Five) persons.

On interrogation they disclosed their identity noted above and also stated that they along with other associates with them had assembled there with a view to commit docoity after

making full preparation in a house at adjacent area. Thereafter all the apprehended persons were searched and due to late night I could not find any independent witness to be present at the time of search and seizure. During search the above noted articles were seized from their possession.

All the articles were seized on 30.06.22 between 01.25 hrs to 02.35 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest, and accordingly myself along with force with arrested accused persons returned back at Pradhan nagar P.S.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused persons namely (1) Suraj Chettri(23) S/O Lt Sasthi Chettri @ Swastri of Darjeeling More ,Gas Godwan,P.S- Matigara,Dist.Darjeeling ,(2) Pritam Gurung @ Pitter (23) S/O Lt Gopal Gurung of Pratap Gown ,P.S-Mirik,Dist.Darjeeling ,(3)Md Raja @ Md Majamil(23) S/O Lt.
