Sir,

In producing herewith two arrested accused person namely 1. Kali Charan Barman 39yrs s/o Lt, Khagen Barman R/o Badlavita near Hebron School PO, Rangia Ps, Matigara Dist, Darjeeling 2. Prasanta Roy 24yrs s/o Sushil Roy R/o Daspara Naharganj PS, Chopra Dist, Uttar Dinajpur A/p Gosainpur Nutan Para Ps, Bagdogra Dist, Darjeeling along with seized articles viz,

- (1) One 7mm improvised fire Arms (Pistol) measuring approx 20cm, butt approx 8cm, barrel approx 15cm fitted with magazine made by iron with complete mechanism recovered from the possession of accused person Kali Charan Barman.
- (2) Two rounds 7.65 mm live ammunition recovered from the possession of accused Prasanta Roy.

I SI Dipanjan Bhadra of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge a written complaint against the above noted two arrested accused persons to the effect that on 03.07.22 evening I, along with force were performing K-35 Mobile van duty at 16.15 hrs received a secret source information that two persons were came with one pistol and ammunition standing at Gosainpur More under the Railway over bridge to sell of their designated customer for wrongful gain illegally and noted the same in GD vide Bagdogra PS GDE No. 108 dated 03.07.22. Accordingly, as per direction of OC Bagdogra PS, at 16.20 hrs myself along with PSI Amit Saibo, ASI Khagen Barman, C/1008 Kanak Roy, VP-02 Pradip Roy and CV/389 Janak Singh left for Gosainpur area to verify the veracity of the information vide Bagdogra PS G.D.E. No. 109 dtd. 03.07.22. At about 16.25 hrs we jointly reached at Gosainpur More and meanwhile called two independent witnesses namely i) Sri Bishal Ghosh 24yrs s/o Bivash Ghosh of Gosainpur Ps Bagdogra Dist. Darjeeling ii) Nipun Ghosh 24yrs s/o Niranjan Ghosh of Gosainpur Ps Bagdogra Dist. Darjeeling and disclosed our identity and informed them about the information and requested them to accompany us in the whole process during search and seizure, if any. After reaching the spot parked the vehicle in a considerable distance on pointed out by the source, I found that two persons were standing at Gosainpur More under the Railway over bridge and talking to each other we cordoned them and on seeing the presence of police they both tried to flee away, out of one fell on the road (Prasanta Roy) while running a hot chase we apprehended said two persons and on being asked they disclosed their identity as mentioned above and during searched I recovered (1) One improvised fire arms from the possession of accused Kali Charan Barman which he concealed on his waist and (2) Two rounds 7.65mm live ammunition from the possession of accused Prasanta Roy which he concealed from his right pocket of pant. On asked, the both apprehended persons stated that on 03.07.22 they procured said arms and ammunition from one person at Chopra Daspara for sale to their designated customer towards Nepal to earn huge money for their livelihood illegally and on demand they failed to produce any valid documents/papers in respect of possession of the said arms and ammunition. Accordingly, I seized the all above noted recovered articles under proper seizure list duly signed by the witnesses and accused persons and packed, labeled & sealed the arms & ammunitions separately on the spot and arrested the both accused persons u/s 41 Cr.P.C. The seizure and arrest made in between 16.30 hrs to 17.35 hrs with maintain all formalities of law with maintain all formalities of law.

I, therefore, pray before you that a specific case may kindly be started against the above noted arrested two accused persons with proper section of law and arrange for investigation.
