Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1450 dated 29.06.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/116 Rohit Mahato,

CV/306 Biswajit Roy and CV/824 Niru Yadav, all of NJP PS, SPC left for NJP Bazar area, 150 NJP to work out the information in hand. At about 22.45 hrs we arrived at NJP Bazar area and being identified by the source I held raid at the shop of the said accused and managed to apprehended him. During interroghation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he faded to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest.
